1. NTPC invites on-line bids on Single Stage Two Envelope Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

2. Brief Scope of Work

Scope of work shall include providing services in monitoring and maintaining of Cooling Water System parameters at NTPC- RAMAGUNDAM Stage – I [200 MW X 3], Stage-II [500 MW X 3] and Stage-III [500MW X 1] at 5-COC (On Magnesium Hardness Basis).

The services shall include providing Hach Colorimeter and all the necessary reagents for the analysis of cooling water, Coupon racks including SS,MS and alloy coupons same as condenser, Deposit monitors, Bio-Fouling monitors, TBC, SRB and Iron Bacteria Slides, Analysis of Cooling water from external agency once in three months for microbiological testing, providing small capacity electronic metering pumps, Chemicals shifting, Chemical preparation, handling, dozing, analysis and report of results. Any other job related to CW-I, II & III chemical treatment to improve the effectiveness of overall system shall be in the scope of vendor and shall be carried out as per the instructions of EIC. Shifting of chemicals from stores/sub-stores to treatment area and shifting of empty cans/carboys/drums from treatment area to designated area, Housekeeping of work area are in the scope of contractor.

Cooling water system is separate for each stage, hence Dosing points are separate for St- I, II and III.

NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources.

4. All bids must be accompanied by Tender Fees (Cost of Bidding Documents submitted through online portal only) and Integrity Pact(if applicable). Integrity Pact shall be submitted as per instruction mentioned in ITB/ SCC.

Any bid without an acceptable Tender Fees (through online payment) and Integrity Pact(**if applicable**) shall be rejected by Employer as being non-responsive and shall not be opened.

5. All bids must be accompanied by BID SECURITY for an amount (as mentioned at Clause 3.0 above).

"ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE (ONLY IN CASE WHERE SECURITY BID IS SUBMITTED THROUGH BG) SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED. IN CASE, THE BID SECURITY IS SUBMITTED THROUGH ELECTRONIC FUND TRANSFER (EFT), BIDDER TO SUBMIT THE PROOF OF E-PAYMENT OF BID SECURITY EITHER IN SEPARATE SEALED

ENVELOPE OR IN THE E-TENDERING PORTAL."

Any bid without an acceptable Tender Fees (through online payment), Bid Security (online or BG) and Integrity Pact(**if applicable**) shall be rejected by Employer as being non-responsive and shall not be opened.

6. Qualifying Requirements for Bidders:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulatedhereunder:

6.1 Technical Criteria:

- **6.1.1** The bidder should have executed work for circulating cooling water treatment and monitoring services including ClO2 system in a thermal/gas power plant within preceding 07(seven) years as on first schedule date of techno-commercial bid submission in any of the following manner: -
 - One (1) order having contract value not less than INR 56.12 Lakh

OR

• Two (2) orders having contract value not less than INR 35.07 Lakh each

OR

• Three (3) orders having contract value not less than INR 28.05 Lakh each

Notes for 6.1.1

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- In case of orders under execution, the quantity of work executed prior to the date of Techno-commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. Incase contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executedby the sub-contractor in support of qualifying requirements.

6.2 Financial Criteria:

- **6.2.1** The Average Annual Turnover of the Bidder should not be less than **Rs. 70.15 Lakh** (Rupees Seventy Lakh and Fifteen Thousand only) during the preceding three (3) completed financial years as onthe date of Techno-Commercial bid opening.
- **6.2.2** In case the bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 7.2.1 above, provided that the net worth of such Holding

Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

- **6.2.3** In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
 - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
 - A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 6.2.4 In cases where audited results for the last preceding financial year as on the date of Techno- Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno- Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 6.2:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as perCompanies Act of India, in vogue.
- 3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- 7. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
- 8. The reference works whose details have been declared in their bid shall only be considered to ascertain the bidder's compliance to the specified qualifying Requirement (QR). The Employer at its discretion may seek any clarification and/or documentary evidence only for the reference works as mentioned above. However, no change or substitution of the reference works by new/additional

plant for conforming to the specified qualifying Requirement shall be sought, offered or permitted".

- 9. 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- **10.** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- **11.** NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
- 12. Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- **13.** The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the NTPC tender website https://eprocurentpc.nic.in. The Bidder would be required to register on the website.

First time users are required to register themselves on NTPC tender website (https://eprocurentpc.nic.in) after filling up the required details. Users whose email address has not been linked to a vendor code allotted by NTPC/ first time users not allotted any vendor code by NTPC, should send a copy of the registration details to the e-mail address specified in this NIT under Address for Communication with following details at least three working days prior to Technical Opening Date:
