## 4.0 Brief Scope of Work and other Specific details:

Supply, Installation, Testing and Commissioning of 210 HP VRF duct able and Non duct able Air conditioner systems at Core 7, 7th floor and upper basement of Core7 and CMSC of 210 HP VRF/VRV duct able and non-duct able AC at Core7, 7th floor and Upper basement of Core7 for 9 years after warranty.

# 5.0 Downloading / Issuance of bidding documents to any bidder shall not construe that bidder is considered qualified.

**6**.0 'Class-I local suppliers' and 'Class-II local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

## 7.0 Qualifying Requirements for Bidders:

- **7.1** The bidder should have executed/ completed similar works in Govt. Deptt. / PSU/ Private institution /organizations in India during the preceding seven (07) years as on the date of techno-commercial bid opening having contract value of any one of the following:
  - a) One executed/completed work having executed value not less than **Rs. 1,04,47,640.00**

OR

b) Two executed/completed works having executed value not less than **Rs. 65,29,770.00** 

OR

c) Three executed/completed works having executed value not less than **Rs. 52,23,820.00** 

**Similar** work includes Supply, Installation, Testing & Commissioning of VRF duct able and Non-duct able Air conditioner systems.

**Note:** (1) The work "**executed**" means the bidder should have achieved the criteria specified in the QR, even if the total contract is not completed / closed.

(2) In case of contracts under execution as on date of bid opening, the value of work completed till the date of bid opening will be considered provided the value of executed work is certified by the employer.

**7.2** The average annual turnover of the bidder, in the preceding three (03) financial years as on the date of Techno-Commercial bid opening shall not be at less than Rs. 1,30,59,547.00/-

## Note:

(a) While computing the turnover other income shall not be considered.

(b) In cases where audited results for the last financial year as on the date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

**8.0** NTPC reserves the right to reject any or all bids or cancel / withdraw the Notice Inviting Tender [NIT] for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
