**1.0** NTPC Limited invites online bids on "**Single Stage Two Envelope Bidding basis**" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

#### 2.0 BRIEF SCOPE OF WORK

The scope of work comprises of the activities and services mentioned in scope of work and as per "Technical Specification/BOQ" as enclosed in respect of Procurement of valves for drain & vent replacement of boilers at NTPC Shaktinagar.

The scope of work shall comprise, but not limited to the supply, testing and inspection of equipment's and materials at manufacturer's works, packing, supply, transportation, transit insurance, delivery to site, unloading, storage including associated civil and structural works if any.

#### NTPC intends to finance subject Package through Internal Resources.

**4.0** All bids must be accompanied by **Bid Security** in the form as stipulated in the Bidding documents.

**5.0** Bidder has to ensure the following documents to be submitted offline/ online, pursuant to ITB Clause 15, failing which bid is liable for rejection

a) Tender Fee: As applicable through online GePNIC portal only

b) Earnest Money Deposit/Bid Security : The Bidder shall furnish, as a part of his Bid an

# Earnest Money Deposit/Bid Security of amount ₹20,00,000/- (Rupees Twenty Lakhs only)

In case of Bidders opting for Bank Guarantee as Bid Security but unable to submit the Original Bank Guarantee in physical form at the tender opening location, before the deadline for submission of bids, following shall also be considered acceptable:

(i) The issuing bank shall intimate through their own official e-mail id to concerned C&M department with a copy to Bidder regarding issuance / extension of Bank Guarantee (BG) along with following documents, before the deadline of submission of bids: -

a) The scanned copy of the BG.

b) SFMS / SWIFT message acknowledgement copy sent to NTPC / Employer's banker stating the date of sending.

c) An undertaking from the issuing Bank strictly as per format enclosed at Annexure-A.

SFMS / SWIFT message must be sent to the NTPC/Employer's bank, details of which are mentioned in Bidding documents.

(ii) Bidders shall also be required to upload the scanned copy of the BG on GePNIC (Fee Cover) / e-tendering portal.

Bidder shall also be required to submit the Original BG in physical form to reach NTPC at the address mentioned in Bidding Documents, not later than 10 days from the date of submission of Techno-Commercial bids or before the Price Bid opening, whichever is earlier, failing which its bid shall be rejected and not considered for further evaluation.

c) Integrity Pact: Applicable (to be accepted in GePNIC GTE option)

**6.0** A complete set of Bidding Document may be downloaded by any interested Bidder from <u>https://eprocurentpc.nic.in/nicgep/app</u>.

Prospective bidders are compulsorily required to provide GSTIN number with Tender Fee.

# 7.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

# 7.1 Technical Criteria:

7.1.1 The bidder should be manufacturer/ authorized dealer/ distributor/ channel partner/ subsidiary of manufacturer of IBR certified high pressure valve(s) and should have supplied actuator operated IBR certified Valves of rating class 2500 or above of size 300 NB or above for 200 MW or above capacity thermal power plant unit in the preceding seven (7) years, prior to the date of techno-commercial bid opening.

7.1.2 The bidder should have supplied high pressure Valves for 200 MW or above capacity thermal power plant unit in the preceding seven (7) years, prior to the date of techno-commercial bid opening meeting the following criteria:

i) Single order of value not less than Rs. 969 Lakhs.

OR

ii) Two orders of value not less than Rs. 606 Lakhs each.

OR

iii) Three orders of value not less than Rs. 485 Lakhs each.

Notes

(a) All values above are excluding of GST/ taxes

(b)The word "executed/supplied" shall mean that the bidder should have successfully completed work(s) under the contract as required at clause 7.1.1 & 7.1.2 above, even if the total contract is not completed / closed.

(c) The work completed in the preceding seven (07) years reckoned from the date of techno commercial bid opening; even if it has been started earlier; will also be considered as meeting the qualifying requirements.

7.2.1 The Average Annual Financial Turnover (AATO) of the bidder during preceding three (03) consecutive financial years as on the date of technocommercial bid opening should not be less than Rs. 12.12 Crores (INR Twelve crore and Twelve lakhs only).

In case the Bidder does not satisfy the financial criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be requested to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Bid Documents, pledging unconditional & irrevocable financial support for the execution of the Contract by the Bidder in case of award.

7.2.2 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:

i) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company

ii) A certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Financial Statements of the Holding Company.

7.2.3 In cases where audited results for the last financial year as on the date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three (03) consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding document stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying financial parameters is not available.

Notes for Clause 2.0 above:

(i) Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

(ii) Other income shall not be considered for arriving at annual turnover figures.

(iii) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.

8.0 'Class-I local suppliers'/ 'Class-I local suppliers and Class-II local suppliers" only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

#### NOTE:

Bidders are requested to give acceptance of being Class-I&II Local Supplier (Minimum Local Content equal to or more than 20%) by accepting the GTE & declaration in Bid Form.

By accepting the MLC provision of GTE it will be considered that:-

"Bidder is 'Class-I & II local supplier' and is meeting the MLC requirement stipulated in Annexure-II to BDS.

Also supplier has not been debarred / banned by any other procuring entity for violation of 'Public Procurement (Preference to Make In India), Order 2017' (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)''.

In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

**9.0** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- **10.0** NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- **11.0** Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- **12.0** Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
