However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. ### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### **QUALIFYING REQUIREMENTS OF NIT**

The bidders who wish to participate in the bidding process shall satisfactorily establish with documentary evidence that they fulfil the following Qualifying Requirements.

#### **Technical Criteria** :-

1.1 The Numerical Relay shall be offered from a manufacturer who has manufactured and supplied and successfully configured at least hundred (100) No's of Numerical Relays with IEC 61850 used for application in protection in EHT/HT/LT system (covering all voltage levels  $\geq 415V$  AC)' These relays should have been in successful operation for at least one (1) year prior to the date as on last date of the month preceding the month of publication of NIT.

1.2 The Bidder should have executed/completed similar orders during the last seven (7) years, as on last date of the month preceding the month of publication of NIT ,having minimum order values as indicated below:

- a) One order of value not less than Rs.567.89 Lakh,  
OR
- b) Two orders, each of value not less than Rs.354.93 Lakh,  
OR
- c) Three orders, each of value not less than Rs.283.94 Lakh

**Similar order Means:** 'supply, installation, commissioning' of numerical relays for protection in EHT/HT/LT system(covering all voltage levels  $\geq 415V$  AC)' individually or as 'integral part of panels'.

*(In case of 'integral part of panels', total panels shall be considered as similar order )*

**Note:**

(i) The word "executed/completed" means the bidder should have achieved the criteria specified in the clause no 1.2 of QR, even if the total Order is not completed/closed. In case any Order is under execution as on last date of the month preceding the month of publication of NIT, the value of supply executed against such Order till such date will be considered provided the same is certified by the Owner/Project Authority.

(ii) For the purpose of arriving at the executed value of order specified at clause 1.2 above, basic amount only shall be considered. In case of a contract inclusive of Taxes, agency has to provide the break-up of basic value and tax.

**FINANCIAL CRITERIA :**

2.1 The average annual turnover of the bidder in the preceding three (3) completed Financial Years as on the date of techno-commercial bid opening, shall not be less than **Rs. 354.93 Lakh** (Indian Rupees Three Crore Fifty Four Lakh Ninety Three Thousand Only).

**Notes**

**i.** Other income shall not be considered for arriving at annual turnover.

**ii.** In case where audited results for the last financial year as on date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno Commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available
