Three POs of the highest executed values of similar work along with BOQs during previous five years from the date of application and Copy of Completion Certificate /Running Bill in support of successful execution of works against the POs to be submitted. 2. Audited Balance Sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered Accountant may be submitted. 3. NSIC / SSI / MSME Registration Certificate 4. PF and Service Tax Registration Certificate 5. Any other documents in addition to the above which the applicant wants to submit.
