**Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).

2. The bidders who already have valid SRM User ID:

a) Login the SRM Portal and click on RFX and Auction button.

b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.

c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.

d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.

e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:

a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till **01/07/2022** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: [Aditya.k@nspcl.co.in](mailto:Aditya.k@nspcl.co.in), [rashmikumari@nspcl.co.in](mailto:rashmikumari@nspcl.co.in)

b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)

c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## **QUALIFYING REQUIREMENT**

Package Name: Procurement of CT Fan Fill for Durgapur PP-2.

Completion Period: 04 months  
QUALIFYING REQUIREMENTS:

### **1) Financial Criteria:**

The average annual turnover of the bidder in the preceding three financial years as on the date of techno commercial bid opening shall not be less than Rs. 52.097 lakhs. (Rupees Fifty-two lakhs and nine thousand seven hundred only)

### **2) Technical Criteria:**

2.1) The bidder should have supply similar CT Fan fill materials for any power plant.

2.2) The agency must have successfully executed similar supply within preceding 7 years reckoned as on the date of techno commercial bid opening having executed value as under:

- a) At least one order of value not less than Rs 41.68 lakhs (OR)
- b) At least two orders of value not less than Rs 26.05 lakhs each (OR)
- c) At least three orders of value not less than Rs 20.84 lakhs each

### **Note:**

1. The word "similar" means that at least one of the items of the order submitted shall contain CT fills material.
2. The word "Executed" means that the bidder should have achieved the progress specified in the QR para 2.2 even if total supply order is not completed/closed. The same shall be supported by documentary evidence issued by the owner/employer such as completion certificate/Joint protocol/Running/Final Bills etc.
3. For financial selection criteria, QR para 1, bidder must submit copy of audited balance sheet and profit & loss account for the specified period. In case where audited results for the last financial year as on last date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case the bidder is not able to submit the certificate from practicing chartered accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
4. Other income shall not be considered for calculation of annual turnover.
5. Values as per clause 2.2 shall be considered inclusive of taxes and duties.

## **NIT Conditions**

3. Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.
4. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
5. Small-scale industries registered with UDYAM shall be exempted for payment of EMD & Tender Fee.  
*(Subject to submission of copy of registration giving details, such as validity, monetary limit, etc.)*
6. NSPCL shall allow purchase preference, as indicated in the bidding documents, to bids from local suppliers as defined in the bidding documents. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
7. Notwithstanding anything stated above, the Employer reserves the right to undertake a physical assessment of the capacity and capabilities including financial capacity and capability of the Bidder / his Collaborator(s) / Associate(s) / Subsidiary(ies) / Group Company(ies) to perform the Contract, should the circumstances warrant such assessment in the overall interest of the Employer.

The physical assessment shall include but not be limited to the assessment of the office/facilities/banker's/reference works by the Employer. A negative determination of such assessment of capacity and capabilities may result in the rejection of the Bid.

The above right to undertake the physical assessment shall be applicable for the qualifying requirements stipulated above.

8. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
