1.0 NTPC Limited (NTPC) invites online bids on “**Single Stage Two Envelope Bidding basis**” from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

NTPC intends to finance subject Package through Internal Resources.

Note: The MSME Benefits as mentioned in Bid Data Sheet (BDS), shall be applicable for Form of Contract/Tender Category” type “categorized as "Services" /" Supply” and not for Form of Contract/Tender Category” categorized as “**Works Contracts**”.

The category of this contract is categorized as ‘Works Contract’, hence, MSE benefits are not available for this contract.

- 4.0** All bids must be accompanied with deposits of **(i) Tender Fee and (ii) Bid Security Deposit (EMD)**. Bid Security Deposit / EMD shall be deposited **only through ‘Online Mode, at GePNIC Portal** and Receipt slip of Bid Security Deposit shall be submitted by the bidder in the Fee cover at GePNIC portal.

Option for Online payment of tender fee is made available at GepNIC/e tender portal. Bidders are advised to avail the facility for online deposit of Tender Fee and EMD.

In case a bidder does not submit / deposit the aforesaid Tender Fee and Bid Security / EMD, then the bid shall be rejected by employer as being non-responsive and shall not be opened.

- 5.0** Bidder has to ensure the following documents to be submitted online, pursuant to ITB Clause 15, failing which bid is liable for rejection

a) Tender Fee: As applicable **(Non-Refundable, to be deposited online only)**

b) Earnest Money Deposit/Bid Security, **to be deposited online Only**

c) Integrity Pact: **Not Applicable**

- 6.0** A complete set of Bidding Document may be downloaded by any interested Bidder from the website <https://eprocurementpc.nic.in/nicgep/app> on payment of Tender Fee online at GepNIC Portal.

Prospective bidders are compulsorily required to provide and GSTN and NIT number with Tender Fee.

7.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

7.1 Technical Criteria:

7.1.1 **The bidder should have supplied, erected / supervised erection and commissioned / supervised commissioning of the combination of offered make of IP based camera and offered make of video management software for CCTV system having installation of minimum TEN (10) nos. CCTV cameras in a single contract which should have been in successful operation for at least one year prior to the date of Techno-commercial bid opening.**

AND

7.1.2 The Bidder should have executed similar works of order values as mentioned hereunder during the preceding seven (7) year as on the date of Techno- commercial bid opening as per the following:

(i) Executed value not less than Rs. 50 lacs in a Single Contract.

OR

(ii) Executed value not less than Rs. 31 lacs each in Two Contracts.

OR

(iii) Executed value not less than Rs. 25 lacs each in three Contracts.

Notes for Clause 7.1 above:

1. Similar work means bidder should have executed orders of supply, erection / supervision of erection and commissioning / supervision of commissioning of CCTV system.
2. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed /closed.
3. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
4. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying In case, bidder has executed reference work under two orders one for supply and one for services separately for the same installation, both the orders shall be considered as a single order for the purpose of evaluation.

5. In case, bidder has executed reference work under two orders one for supply and one for services separately for the same installation, both the orders shall be considered as a single order for the purpose of evaluation.
6. For arriving at the executed value of work specified above, basic amount only shall be considered. In case of contract is inclusive of taxes, bidder should provide the break-up of basic value and taxes.

7.2 Financial Criteria

7.2.1 The Average Annual Turnover of the Bidder should not be less than Rs. 62 lacs (Sixty-Two Lacs Only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.

7.2.2 In case the bidder does not satisfy the financial criteria, stipulated above (Cl. – 7.2.1) on its own, its holding company would be required to meet the stipulated turnover requirements above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the holding company, supported by Board Resolution of the holding company, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

7.2.3 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification:

- (a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.
- (b) A certificate from the CEO/CFO of the Holding Company as per the format enclosed in the bid documents, stating that the unaudited unconsolidated financial statements form part of the consolidated annual statements of the Holding Company.

7.2.4 In cases where audited results for the last preceding financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for Clause 7. 2 above:

1. Other income shall not be considered for arriving at annual turnover.
2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

Regarding Financial Certificate(s) / Statement(s) / Audited Balance Sheets, bidders should note and comply the following:

"Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI)."

- 8.0 'Class-I local suppliers' only are eligible** to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

NOTE:

Bidders are requested to give acceptance of being Class-I Local Supplier (Minimum Local Content equal to or more than 60%) by accepting the GTE & declaration in Bid Form. By accepting the MLC provision of GTE, it will be considered that: -

"Bidder is 'Class-I local supplier' and is meeting the MLC requirement stipulated in Annexure-II to BDS.

Also, supplier has not been debarred / banned by any other procuring entity for violation of 'Public Procurement (Preference to Make in India), Order 2017' (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)".

In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

- 9.0** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- 10.0** NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 11.0** Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- 12.0** Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
