1.1.2	The bidder should have supplied and/or applied paint on "new/old" steel surface of any Industrial structures within preceding seven (07) years prior to the date of Techno-Commercial bid opening, in any of the following manner: A. One (1) order having executed value not less than Rs. 158.0 Lakh OR
	B. Two (2) orders having executed value not less than Rs. 99.0 Lakh each OR
	C. Three (3) orders having executed value not less than Rs. 79.0 Lakh each
	 Notes for Technical Criteria: The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed. In case, the bidder (the epoxy / enamel paint manufacturer) has executed the above works through their authorized applicators, the bidder shall submit the credentials of applicator (like work orders by epoxy paint manufacturers) duly certified by the bidder.
