1.0 Aravali Power Company Private Limited (APCPL) invites online Bids on 'Single Stage Three Envelope' bidding basis (Envelope-I: Bid Security Declaration form, Envelope II: Techno- Commercial Bid & Envelope-III: Price Bid) from eligible Bidders for aforesaid Package as per the scope of work briefly mentioned hereinafter.

2.0 Salient Technical Features

A. Brief Scope of Work

The scope of work under this package shall include supply, loading, transport and delivery of agro residue based biomass pellet at APCPL/ IGSTPP site.

Unloading shall be in the scope of APCPL at Indira Gandhi Super Thermal Power Project (IGSTPP) Jharli, provided pellets are loose filled in the carriage vehicle. Carriage vehicle should be fully covered and waterproof during transportation to prevent the material from rain, sunlight and to prevent dusting.

If supplier supplies the material packed in bags, consignment shall not be accepted or supplier shall unload the material at his own cost. In that case, for any extra halt of carriage vehicle, demurrage shall not be payable by APCPL.

The pellets supplied shall adhere to the technical specification given in tender document.

3.0 APCPL intends to finance the aforesaid Package through Domestic Funds.
