8.2	<b>Financial criteria :</b>
8.2.1	The Average Annual Turnover of the Bidder, should not be less than <b>Rs. 60 Lakh (Rupees Sixty lakh only)</b> during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
8.2.2	In case the bidder does not satisfy the financial criteria, stipulated at Cl. 8.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 8.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. **Also supplier has not been debarred / banned by any other procuring entity for violation of ‘Public Procurement (Preference to Make In India), Order 2017’ (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)’.**

11. NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
12. Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder’s representatives who choose to attend the bid opening.
13. Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
