1.0 PVUN invites online bids on "**Single Stage Two Envelope Bidding basis**" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

2.0 BRIEF SCOPE OF WORK

The scope of work comprises of Supplying and Laying of 11KV HT Cable with other accessories by means of Underground in HDPE pipe by HDD technology and through wall mounted trays from miscellaneous switchgear room to main township at PVUN Ltd.

4.0 All bids must be accompanied by **Tender Fee and EMD for an amount mentioned at Clause 3.0 above** in the form as stipulated in the Bidding documents. EMD and Tender fee shall be submitted offline in a separate sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE TENDER FEE AND EMD IN A SEPARATE SEALED ENVELOPE AT THE ADDRESS MENTIONED IN THE BIDDING DOCUMENT BEFORE STIPULATED DATE & TIME OF SUBMISSION OF BID SHALL BE REJECTED BY THE EMPLOYER AS BEING NONRESPONSIVE AND SHALL NOT BE OPENED.

- 5.0 Bidder has to ensure the following documents to be submitted offline, pursuant to ITB Clause 15, failing which bid is liable for rejection
 - a) Tender Fee: As applicable
 - b) Earnest Money Deposit/Bid Security:As Applicable.

Any bid not accompanied by Bid security, Tender fee, Integrity Pact shall be rejected by the Employer as being non-responsive and shall be rejected without being opened.



Tender fee and EMD (in case of offline payment) as mentioned above is required to be submitted in separately sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

7.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirementsstipulated hereunder:

7.1 Technical Criteria

PVUN 7.1.1	The bidder should have supplied, erected, tested and commissioned 11 kV or higher-grade cables which must be in successful operation for a period of one (01) year within the preceding seven (07) years prior to the date of Techno-Commercial bid opening.
AND	
	b) The bidder must fulfill the criteria as below:
	At least one work order having value not less than INR 7.2 Crore.
	OR At least two work orders, each having value not less than INR 4.5 Crore.
	OR At least three work orders, each having value not less than INR 3.6 Crore.
7.2	Financial Criteria
	a) The average annual turnover of the bidder in the preceding three (03) financial years as on the last date of the month preceding the month in which Notice Inviting Tender is published shall not be less than Rs. 09 crore (Indian Rupees Nine Crores only).
	In case a Bidder does not satisfy the annual turnover criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Techno Commercial bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.
	(b) The Net Worth of the Bidder as on the last day of the preceding financial year, of the date of Techno-commercial Bid opening, shall not be less than 100% of the bidders paid up share capital. In case the Bidder meets the requirement of Net Worth based on the strength of its Subsidiary (ies) and/or Holding Company and/or Subsidiary (ies) of the Holding company wherever applicable, the Net Worth of the bidder and its Subsidiary (ies) and/or Holding company and/or Subsidiary (ies) of the Holding company, in combined manner should not be less than 100% of their total paid up share capital. However individually, their Net Worth should not be less than 75% of their respective paid up share capitals. Net worth in combined manner shall be calculated as follows:
	Net worth (combined) = [(X1+X2+X3) / (Y1+Y2+Y3)] x 100
	Where X1, X2, X3 are individual net worth which should not be less than 75 % of the respective paid up share capitals and Y1,Y2,Y3 are individual paid up share capitals.
	(c) In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the un-audited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes





8.0 **Class-I local suppliers**'/ <u>'Class-Hocal suppliers and Class-II local suppliers</u>" only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

OR

Bids from 'Class I local suppliers' as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT shall be eligible for purchase preference. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

NOTE:

Bidders are requested to give acceptance of being Class-I Local Supplier (Minimum Local Content equal to or more than 60%) by accepting the GTE & declaration in Bid Form.

By accepting the MLC provision of GTE it will be considered that: -

"Bidder is 'Class-I local supplier' and is meeting the MLC requirement stipulated in Annexure-I to BDS. Also supplier has not been debarred / banned by any other procuring entity for violation of 'Public Procurement (Preference to Make In India), Order 2017' (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)".

In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

- 9.0 PVUN reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 10.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- 11.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
