- **1.1.1** The bidder should be manufacturer of OPC Cement and shall submit copy of valid BIS license(s) in support of the same.
- **1.1.2** The bidder should have supplied 'OPC and/or PPC' Cement within the preceding seven (07) years prior to the date of techno commercial bid opening, meeting the following criteria:
  - Single executed order of cement quantity not less than 8000 MT.

OR

Two executed orders of cement quantity not less than 5000 MT each.

OR

• Three executed orders of cement quantity not less than 4000 MT each.

#### **NOTES:**

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the Quantity of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.

#### 1.2 Financial Criteria:

- 1.2.1 The Average Annual Financial Turnover (AATO) of the bidder during preceding three (03) consecutive financial years as on the date of techno- commercial bid opening should not be less than **Rs. 433 Lakhs (Rupees Four crores and Thirty three lakhs Only).**

- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
