#### **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- **2.** The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFx and Auction button.
- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till 19/01/2023 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

# **QUALIFYING REQUIREMENT**

Name of Work: "ANNUAL JOB CONTRACT FOR ASSISTANCE IN OPERATION AND HOUSEKEEPING OF MAIN PLANT & OFFSITE AREA IN DURGAPUR PP-III (2X20 MW) PLANT".

#### 1. Financial criteria:

The average annual financial turnover of the bidder in the preceding three(03) financial years from the date of Techno-commercial bid opening should not be less than **Rs. 276.60** Lacs. (Rupees Two Hundred Seventy Six Lacs and Sixty Thousands Only).

#### 2. Technical Criteria:

- 2.1) The bidder should have successfully completed / executed work (s) i.e. Operation assistance/ Operation support/ House Keeping/ Up-keeping/ Equipment clearing/ Manpower assistance work of any Power plant/ Process industries/ Manufacturing Industries/ Township/ Commercial complex.
- 2.2) The bidder should have executed similar work mentioned in 2.1 during preceding seven(07) years prior to the date of techno-commercial bid opening, having executed values as under:
  - a) Single contract completed / executed value not less than **Rs 221.28 Lacs**. (including Taxes & Duties).

OR

b) Two contracts completed / executed value not less than **Rs 138.30 Lacs each**. (including Taxes & Duties).

OR

c) Three contracts completed / executed value not less than **Rs 110.64 Lacs each**. (including Taxes & Duties).

#### **Notes:**

- 1) The word 'executed' means that the bidder should have achieved the progress specified in the Techno- Commercial bid, even if total contract / order is not completed / closed. The same shall be supported by documentary evidence issued by the owner / employer such as Completion Certificate /Joint Protocol / Running Bill / Final Bill.
- 2) The word "similar works" is defined in para 2.1 of technical Criteria.
- 3) For Financial criteria mentioned in QR, bidder must submit copy of audited balance sheet and profit and loss account for the specified period. In case, where audited results for the last financial years on the last date of Techno-commercial bid opening are not available, the financial results certified by a practicing chartered accountant shall be considered acceptable. In case bidder is not able to submit the certificate from the practicing chartered accountant certifying its financial parameters, the audited results of the three(03) consecutive financial years preceding the last financial year, shall be considered for evaluating the financial criteria.
- 4) All values mentioned in 2.2 shall be inclusive of all taxes and duties.
- 5) Other income shall not be considered for calculation of annual turnover.
- 6) Necessary documentary evidence in support requirements of QR are to be furnished by the bidder.

### **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.
