### II. Brief Scope of Work

Brief scope of work includes all jobs required for transportation of 5 (Five) LMT coal from MCL mines in Talcher area to APCPL Jhajjar under Rail-cum-Sea-cum-Rail (RSR) mode through Eastern Port (designated load port) to any port in Western India (designated discharge port).

#### V. Qualifying Requirements for Bidders:

The qualifying requirements, detailed technical specifications, and Bill of Quantities (BOQ) will be intimated shortly via corrigendum through this website only. Bidders are advised to visit website regularly to keep themselves updated.

- VI. APCPL reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
- VII. The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the APCPL tender website <a href="https://etenders.gov.in">https://etenders.gov.in</a>. The Bidder would be required to register on the website.

- X Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- XI 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- XII Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
