 - Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
 - Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
 - Tender document fee should be submitted on-line only.
 - Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could able to "Create Response" and submit the bids against the Bid invitation into the system.
- New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:**

QUALIFYING REQUIREMENTS(QR)

1. Financial Criteria:-

1.1 The average annual turnover of the bidder, should not be less than **INR 117.92 Lakhs (Rupees One hundred seventeen Lakhs & Ninety two Thousand only)** during the preceding three (3) completed financial years as on 7 (seven) days prior to the date of Techno commercial bid opening.

2. Technical criteria:-

2.1 The Bidder should have “executed” the work of laying of over ground/underground pipeline including required fittings and other related works within preceding 7 (seven) years prior to the date of Techno commercial bid opening in any of the following manner :-

a. One (1) order of executed value not less than **INR 94.34 Lakhs (Inclusive of Taxes & Duties)**

OR

b. Two (2) orders of executed value not less than **INR 58.96 Lakhs (Inclusive of Taxes & Duties)**

OR

c. Three (3) orders of executed value not less than **INR 47.17 Lakhs (Inclusive of Taxes & Duties)**

3. Notes:-

- 1) The word “executed” mentioned above means that the bidder should have achieved the criteria specified in 2.1 above, even if the total contract is started earlier and/or is not completed/closed. In case of contracts under execution as on date of techno- commercial bid opening, the value of executed work till such date will be considered provided the same is certified by the Employer.
- 2) Other income shall not be considered for arriving at annual turnover.
- 3) In cases where audited results for the last preceding financial year as on the date of techno commercial BID opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three (3) consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters of bidder.
- 4) All values mentioned at sl. 1 & sl. 2 above shall be inclusive of all Taxes & Duties.
- 5) Necessary documentary evidence in support requirements of QR are to be furnished by the Bidder.
