1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific ATC

1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Re quirements stipulated hereunder:

1.1 Technical Criteria:

1.1.1 The applicant should be a manufacturer of Hot Insulation (Rock Wool Matt ress /Ceramic 'Pad/ Fibre' Blanket) and should have supplied Ceramic 'Pad/Fibre ' Blanket to any Industry within preceding 07 years prior to the date of bid opening.

1.1.2 The bidder should have executed the work of "Supply and/or apply of Hot I nsulation (Rock Wool Mattress / Ceramic 'Pad/Fibre' Blanket)" to any Industry wi thin preceding seven (07) years prior to the date of Techno-Commercial bid ope ning, in any of the following manner:

A. One (1) order having executed value not less than Rs. 82 Lakh

OR

B. Two (2) orders having executed value not less than **Rs. 51 Lakh** each

OR

C. Three (3) orders having executed value not less than Rs. 41 Lakh each.

Notes for Technical Criteria:

1. The word "Executed" mentioned above means that the bidder should have ac

hieved the criteria specified above, even if the total contract is started earlier a nd/or is not completed/closed.

2. In case of orders under execution, the value of work executed prior to the dat e of Techno- Commercial bid opening duly certified by bidder's client shall be co nsidered acceptable.

3. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified b y owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

4. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should pr ovide the break – up of basic value and taxes.

1.2 Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 1 O3 Lakh (Rupees One Hundred & Three lakh only)** during the preceding th ree (3) completed financial years as on the date of Techno-Commercial bid ope ning.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1. 2.1 above on its own, its Holding Company would be required to meet the stipul ated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at le ast equal to or more than the paid-up share capital of the Holding Company. In s uch an event, the bidder would be required to furnish along with its Techno- Co mmercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging un conditional and irrevocable financial support for the execution of the Contract b y the bidder in case of award.

1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of t he bidder can be considered acceptable provided the bidder further furnishes th e following documents for substantiation of its qualification.

 \cdot Copies of the unaudited unconsolidated financial statements of the bidder alon g with copies of the Audited consolidated financial statements of its Holding Co

mpany.

 \cdot A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated finan cial statements form part

of the Consolidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on t he date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered accep table. In case, Bidder is not able to submit the Certificate from practicing Charte red Accountant certifying its financial parameters, the audited results of three c onsecutive financial years preceding the last financial year shall be considered f or evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Tech no-Commercial bid opening and the Certificate from the practicing Chartered Ac countant certifying the financial parameters is not available.

Notes for 1.2:

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascrib ed to them as per Companies Act of India, in vogue.

iii. Net worth means the sum total of the paid up share capital and free reserves . Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the ass ets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent no t adjusted or written off, if any, shall be reduced from reserves and surplus.
