## Instruction for e-bidding:

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. <u>The bidders who already have valid SRM User ID:</u>
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Tender document fee should be submitted on-line only.
  - e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could able to "Create Response" and submit the bids against the Bid invitation into the system.

# 3. <u>New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:</u>

- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## QUALIFICATION REQUIREMENTS(QR)

## Technical Criteria:-

## **1.0 Qualifying Requirements of Bidders:**

In addition to the requirements stipulated in Section ITB (Instructions to Bidder), the bidder should also meet the qualifying requirements stipulated hereunder:

**01.** The bidder must have executed the work of "Fabrication and/or Erection of Steel Structures/ Piping/ Tanks" in thermal power plant / Refineries/ Integrated steel plant in any NSPCL or NTPC Stations/NTPC Joint Venture stations/SEBs/Govt./Semi Govt./PSU/"NSE or BSE enlisted Company" during preceding seven (07) years prior to date of techno-commercial bid opening as per the following criteria.

- a. Three works/orders each costing not less than Rs. **23.604**lakhs(inclusive of tax & duties) Or
- b. Two works/orders each costing not less than Rs. **29.505** lakhs (inclusive of tax & duties) Or
- c. One works/order costing not less than Rs. **47.208** lakhs (inclusive of tax & duties).

## Financial Criteria:-

**02.** Average annual financial turnover of the bidder during preceding three (03) financial years prior to date of techno-commercial bid opening shall not be less than INR **59.01 Lakhs(Rupees Fifty nine lakhs one thousand only)**.

## Note:

(a) The word "executed" mentioned in clause 01 means that the bidder should have achieved the criteria specified in clause 01 with ANY of the following conditions:

Case-I: The work/order is started earlier (prior to the period stipulated in Clause-01 but completed within the stipulated period as mentioned in clause 01. In such cases, entire executed value of the relevant work vide that work order shall be considered for evaluation. Case-II: The work/order is started and completed within the stipulated period as mentioned in clause 01.

Case-III: The work/order is started within the stipulated period as mentioned in clause 01 but not completed as on the last date of stipulated period. In such cases, "In Progress" executed value of the relevant work vide that work order as on the last date of stipulated period, shall be considered for evaluation.

## **Remarks**:

(i) Any of the above cases shall be supported by documentary evidence issued by the owner.(ii) In case of composite work/BOQ, the bidder shall have to furnish Certificate from owner

certifying the value of specific nature of work, as mentioned in Clause-01.

(iii) Reference work executed by a bidder as a sub-contractor may also be considered. In such a case, the bidder shall submit the documentary evidence in support of above.

(b) Other income shall not be considered for arriving at annual turnover.

(c) In cases where audited results for the last financial year as on the date of the Techno-Commercial Bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying that financial parameters is not available.

(d)All values mentioned at sl. 1 & sl. 2 above shall be inclusive of all Taxes & Duties.
