2. Brief Scope of Work : The contractor shall provide preferably Telangana State Registered Taxies (Toyota Etios or its equivalent, Toyota Innova Crysta or equivalent) of Model 2019 or later. The cars/taxies shall be provided at our office at Kavadiguda, Secunderabad or any other place as intimated to the contractor for travel within or outside Telangana State as and when required.  
However, for VVIP and major events, the party has to supply latest model vehicles not older than one year on the date of requisition. This may be approximately, 05 per cent of total quantity in PO. The contractor shall provide well-behaved drivers in proper uniform along with mobile phone having knowledge of different routes as well as repair of cars and valid driving license. Micro and Small Enterprises (MSEs) having Udyam Registration for Goods produced and Services rendered shall only be eligible for MSE benefits.

**In case of an upward change in terms of investment in plant and machinery or equipment or turnover or both, and consequent re-classification, an enterprise shall continue to avail of all non-tax benefits of the category (micro or small or medium) it was in before the re-classification, for a period of three years from the date of such upward change.**

**5. Qualifying Requirements for Bidders:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

**5.1 Technical Criteria**

5.1.1 The bidder should have a minimum fleet of fourteen (14) registered commercial vehicles of variants of Sedan Car(s) and SUV Car(s), out of which the agency should have 40% (6nos) vehicles registered in their name and balance can be either operated on lease basis or holding Power of Attorney in their favour to operate the vehicles on commercial basis.

5.1.2 The bidder should have executed the work of Deployment vehicle(s) in any 'Govt. Dept' / 'Public Sector Organisation' / 'Private sector companies' within the preceding seven (7) years prior to the date of TechnoCommercial bid opening in any of the following manner:.

A. One (1) order having executed value not less than Rs. 28 lakh

OR

B. Two (2) orders having executed value not less than Rs. 18 lakh each

OR

C. Three (3) orders having executed value not less than Rs. 14 lakh each

**Notes for Technical Criteria:**

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.

2. In case of orders under execution, the value of work executed prior to the date of Techno Commercial bid opening duly certified by bidder's client shall be considered acceptable.

3. The type of fleet of vehicles should be as below and having minimum one number in each category:

A. SEDAN CAR: Category of cars having engine capacity 1100cc and above.

B. SUV CAR: Category of cars having engine capacity 1800cc and above.

4. For arriving at the executed value of work specified above, basic amount only shall be considered (excluding fuel cost & toll/parking charges wherein the fuel cost & toll/parking charges are reimbursable as per contract). In case contract is inclusive of taxes, bidder should provide the break – up of basic value, reimbursement (towards toll / parking charges) & taxes.

**5.2 Financial Criteria:**

5.2.1 The Average Annual Financial Turnover (AATO) of the bidder during preceding three (03) consecutive financial years as on the date of Techno -Commercial bid opening should not be less than Rs. 35 Lakh (Rupees thirtyfive lakh only)

5.2.2 In case the Bidder does not satisfy the financial criteria, stipulated at Cl. No. 5.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. No.5.2.1 above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Bid Documents, pledging unconditional & irrevocable financial support for the execution of the contract by the bidder in case of award.

5.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:

- a. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
- b. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated annual financial statements of the Holding Company.

5.2.4 In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practising Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practising Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno commercial bid opening and the Certificate from the practising Chartered Accountant certifying the financial parameters is not available.

**NOTES for 5.2 above:**

1. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
  2. Other income shall not be considered for arriving at annual turnover.
  3. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
6. Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
7. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators /associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.

The physical or any mode of assessment/verifications by Employer shall



include but not be limited to the assessment/verifications of office/ facilities/ banker's/ submitted reference works in lieu of credentials. A negative determination of such assessment of credentials/capacity/capabilities may result in rejection of the bid

8. 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
9. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

10. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
11. NTPC reserves right to amend any bid/tender conditions through appropriate CORRIGENDUMS published in the portal AT ANY TIME. NTPC also reserves the right to extend/change the bidding schedule through publishing necessary CORRIGENDUMS in the portal if the situation demand so AT ANY TIME.
