General Details about NTPC Vindhyachal:

NTPC XXXX, located at XXXX having a total installed capacity of **4760 MW**, is engaged in the business of generation and sale of bulk power.

To utilize the fly ash in gainful and sustainable manner as per the provisions of extant MOEF&CC Gazette Notification and promote utilization of fly ash as resource material, NTPC Vindhyachal intends to issue some of its Pond on free of cost to Road Projects / Flyover embankments / Dams / Mines / Shoreline Protection structures in coastal Districts (as per extant MoEF&CC Notification and policy). Transportation cost (to the extent requested by the successful Bidder – with the provision that agency requesting the least support shall be given higher preference) shall be borne by NTPC Vindhyachal within limits and as per criteria set by extant Notification, Advisory and Policy. Preference shall be given to requests having minimum cost implication to NTPC for transportation.

To facilitate this, NTPC Vindhyachal invites Expressions of Interest for above, for a period of 01 (One) year, from its **6 X 210 MW Stage - I units** and **7 X 500 MW Stage - II, III, IV, V units**. Further details regarding this Expression of Interest (Eoi) are as follows:

Allocation of pond ash Quantity:

Based on the time of receipt of responses to Eoi, pond ash shall be allocated to various bidders for qualified projects, keeping in view minimum cost implication to NTPC for transportation of Ash, till the available offered quantity is exhausted. pond ash shall be issued free of cost.

In case the same Bidder gets some allocation against the last Auction Process and / or Eoi for free issue with transportation by bidder and also against this Eoi, then the Ash quantity allocated against this Eoi shall be issued to that Bidder, only after the Bidder completes the lifting / drawl of the allocation against the Auction Process and / or Eoi for free issue with transportation by bidder as applicable.

Daily allocation of fly ash shall be done as per monthly requisition containing a list of their day wise requested quantity for each month submitted by the bidder by 22nd of the previous month and availability of Ash at the Station on that particular day. The ash shall be delivered to designated site / location as indicated in the requisition through transporters appointed by NTPC for the purpose. Bidder shall ensure timely unloading of the ash at destination and release of vehicles in reasonable time.

Part 4: Terms and Conditions and General Guidelines:

1. Pond ash shall be issued from, the designated area of Ash Dyke(s) / Pond(s) or other location as decided by EIC, to the Successful Bidders (or their authorized representatives as may be agreed to in writing by the EIC based on approval by HOP), considering Operational and Safety issues of Ash dyke.
2. Bidders shall make themselves aware of the various extant Rules, Procedures, Safety norms, Environmental and Sustainability Guidelines etc. and carry out their activities in full compliance with the same.
3. No person / agency shall be allowed to lift ash without due permission from TPP.
4. General facilitating measures for lifting of Ash viz. Common Approach / ramp, general area fugitive dust suppression, etc. shall be in the scope of NTPC. However, job specific facilitation viz. approach / ramp to specific allocated area and local fugitive dust suppression shall be in the scope of the recipient ash user.
5. Depending upon operational convenience, safety, etc. EIC can schedule the lifting of Ash from Designated storage area by different agencies, which shall be binding upon the agencies. The schedules and deployment may be worked out / altered based on periodic meetings between concerned stakeholders.
6. Statutory / regulatory compliances shall be binding upon all the Bidders and verifiable by TPP.
7. On allocation of pond ash against this EoI, Successful Bidders shall submit affidavit on Non – judicial stamp paper of requisite value, certifying the complete Utilization of issued Pond ash, in adherence with the provisions of the extant Notification and other applicable statutory regulations. This affidavit, in prescribed format, shall be submitted on Half Yearly basis to the EIC.
8. In case of any liability on TPP, in any manner that arises due to non-compliance of any Environmental and Transportation Norms, Rules, Guidelines and Statutory provisions by the successful Bidder or its representative / agent, during the course of execution and for future obligations (if any) by way of omission or commission, the Bidder shall keep TPP effectively indemnified of any such liability. An indemnity bond shall be submitted before start of lifting of Ash.
9. Statutory / regulatory compliances (CTE/CTO from SPCB/CPCB, End user certificate, etc.) shall be binding upon all the Bidders and verifiable by NTPC.
10. Interested and eligible Bidders executing Project shall have to submit tentative time schedule of the project along with Expression of Interest.
11. Interested and eligible Bidders shall have to submit End User Certificate for utilisation of supplied Pond Ash.
12. All Eligible Projects shall source Ash from Thermal Power Plants (TPPs) closest to their Project. Allocation of Ash by TPP shall be in compliance with the same.
13. It shall also be the responsibility of the successful Bidder to ensure that the Ash sent from the TPP is facilitated for quick unloading and release of vehicle.
14. NTPC reserves its right to take appropriate action as deemed fit, in case information / details provided are found false even at a later date.

- 1.0 The Ash Recipient hereby undertakes to fully and irrevocably indemnify and keep indemnified the TPP against any and all of various liabilities of whatsoever nature, which may arise due to violation / Non – compliance of any applicable norms / rules / regulations/ Guidelines / laws including MOEF&CC Guidelines during the course of lifting or handling of Ash and for future obligations (if any), by way of omission or commission by the Ash Recipient or its representatives / agents for Ash issued by the TPP to the Ash Recipient vide order / permission letter no.
- 2.0 This Indemnity Bond shall be valid till six (6) calendar months after the scheduled date / actual date of complete lifting of allocated Ash Quantity, whichever is later.
