 - Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could able to "Create Response" and submit the bids against the Bid invitation into the system.

QUALIFYING REQUIREMENTS (QR)

1. FINANCIAL CRITERIA:

1.1: **Turnover:** The average annual turnover of the bidder in the preceding 03(three) Financial years as on the date of Techno Commercial bid **opening shall not be less than 9.34 lakhs. (Rupees Nine Lakhs Thirty Four thousands only)**

2. TECHNICAL CRITERIA

- i) The agency should have valid PF and ESI code.
- ii) The agency should have ownership of at least one commercial LMV or should have a valid agreement with vehicle owner for engagement/hiring on commercial basis.

Note:

- For financial selection Criteria, QR Para 1, Bidder must submit copy of Audited balance sheet and Profit & loss Account for the specified period. In case, where audited results for the Last Financial year as on date of technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
- Other Income shall not be considered for calculation of Annual Turnover.
