1. Fly Ash Bricks shall be issued in minimum quantity of **2000 Nos.** from the NTPC Mouda to the Successful bidder (or their authorized representatives as may be agreed to in writing by the EIC), considering actual availability of fly ash bricks.
2. Fly ash bricks loading at NTPC Mouda, transportation and unloading at customer site shall be in the Scope of the Bidder/Customer/Buyer.
3. Bidders shall submit for permission of their vehicles, that they intend to use for transportation of bricks, to EIC along with specified documents like registration, license, insurance, vehicle fitness etc. EIC shall arrange to verify the same and issue permits to vehicles as per prevailing practice adopted at the Station.
4. Request shall be made at least 2 working days prior to the intended loading date. Govt holidays to be avoided for loading.
5. Agency shall submit the receipt of full payment to specified account by designated mode of payment (NTPC Customer payment gateway portal). On receipt of payment and document verification of vehicle EIC/representative shall issue "Brick Issue Permit/Challan" specifying date of issue.
6. Depending upon operational convenience, safety, etc. EIC can schedule or reschedule the lifting of ash bricks.
7. Road Permits, Operator / Driver Licenses, Insurance etc. for the deployed Vehicles shall be submitted at the time of start of work (and when new and / or additional vehicles are deployed) and thereafter whenever demanded by the EIC for verification. The vehicles shall be in fit condition for safe operation.
8. NTPC reserves the right to take appropriate action or complete closure as deemed fit, in case information/details provided by the bidder are found false even at any later date.
9. Non – compliance shall attract penal actions ranging from fine to termination of contract / agreement / issue of Fly Ash Bricks as decided by EIC
