Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered

service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

TECHNICAL CRITERIA:

The bidder should have executed work(s) for 'Operation Assistance / Operation / Operation & maintenance/ Maintenance' **including bunker/hopper chocking removal** in a coal-based thermal power plant within preceding 07 (seven) years prior to date of Techno-Commercial bid opening in any of the following manner:

(a) One (1) order having executed value not less than Rs. 82 Lakh

OR

(b) Two (2) orders having executed value not less than Rs. 51 Lakh each

OR

(c) Three (3) orders having executed value not less than Rs. 41 Lakh each

NOTES:

1 The word "Executed" mentioned above means that the bidder should have ac hieved the criteria specified above, even if the total contract is started earlier a nd/or is not completed/closed.

- 2 In case of orders under execution, the value of work executed prior to the dat e of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 3 Reference work executed by the bidder as a sub-contractor may also be consi dered provided the certificate issued by main contractor is duly certified by ow ner specifying the scope of work executed by the sub-contractor in support of q ualifying requirements.
- 4 For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 5 "Reference works executed by the bidder, as a member of joint Venture / Consortium / Associate can also be considered provided:
- (a) The allocation of scope of work between the partners of the joint Ventures / consortium / Associate is clearly defined in the executed joint venture agreeme nt / consortium agreement / deed of joint undertaking and the bidder's scope of work and break-up of quantities executed by them as individual contribution in the joint Venture / Consortium / Associate, duly authenticated by the Project Au thority/Owner, meet the relevant provisions of eligibility criteria.
- (b)In case the reference work has been executed by the bidder in an integrated joint venture wherein allocation of scope of work and break-up of quantities bet ween the partners is not clearly specified in the integrated joint venture Agree ment, then for establishing the eligibility as per technical criteria 1.1.1 of QR, the credit of executed quantities can be claimed by the bidder in the ratio of bid der's share in the integrated joint Venture Agreement, provided the applicant establishes that it regularly undertakes works mentioned in QR. The executed works/ quantities by the integrated joint venture shall be duly authenticated by the Project Authority/owner."

FINANCIAL CRITERIA:

The Average Annual Turnover of the Bidder, should not be less than **Rs. 102 Lakhs (Rupees One Crore T wo lakh only)** during the preceding three (3) completed financial years as on the date of Techno-Commerc ial bid opening.

In case the bidder does not satisfy the financial criteria, stipulated at Cl. 3.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 3.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno- Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging uncondition all and irrevocable financial support for the execution of the Contract by the bidder in case of award.

In case the bidder is not able to furnish **its audited financial statements on stand-alone entity basis**, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding do cuments, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

In cases where audited results for the last preceding financial year as on the date of Techno-Com mercial bid opening are not available, the financial results certified by a practicing Chartered Acco untant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicin g Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Furt her, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding docu ments stating that the Financial results of the Company are under audit as on the date of Techno-Commer cial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

- 1. **Other income** shall not be considered for arriving at annual turnover figures.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
- 3. **Net worth** means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, a ny debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which share a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
