- 1. NTPC invites online bids on **Single Stage Two Envelope Bidding Basis** for aforesaid Package, as per the Scope of Work mentioned hereinafter.
- 2. A complete set of Bidding Documents may be downloaded by any interested Bidder from the website https://gem.gov.in. The tender is invited under e-tendering process.
- 3. This NIT is published on limited tender basis and is not an open invitation to quote. Participation in this tender is by invitation only and is limited to the shortlisted entities for this tender. Bids received from uninvited entities shall be treated as unsolicited and are liable to be rejected.

Following consultants/firms are eligible for participation in this tender:

Consultants/Firms approved by East-Central (E.C.) Railways to undertake the work of preparation of feasibility report of Private Railway Siding works as on last date of submission of bid and shortlisted by NTPC.

#### Note:

Only the Consultants/Firms which have been shortlisted by NTPC from the list of East-Central (E.C.) Railways can participate in the subject tender, subject to their registration on the GeM portal. The shortlisted Consultants/Firms shall be given an email regarding participating in the subject Tender.

Participating consultants/firms shall submit the documentary evidence along with their Bid to establish the above condition.

#### 4. SCOPE OF WORK

The detailed scope of work shall be as per scope defined in the Vol-II,TOR of Bidding Document No. CS-1150-182-9.

- 5. NTPC intends to finance the subject package through Own Resources.
- 6. Dates for Bid Submission and Opening shall be as per the following schedule:

7. All bids must be accompanied by Bid Security for an amount of INR 50,000/- (Rupees Fifty Thousand only) as per the provision of Instructions to Bidders (ITB). Bid security should be through Electronic Fund Transfer only.

"ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED. BIDDER SHALL SUBMIT THE PROOF OF E-PAYMENT OF BID SECURITY IN THE Gem Portal."

### HOWEVER, MSEs\* SHALL BE EXEMPTED FROM PAYING BID SECURITY.

\*Micro and Small Enterprises (MSEs) registered with Udyam Registration Portal as per MSMED Act 2006 for goods produced and services shall be eligible for MSE benefits.

Applicable relevant MSME Certificate should be submitted online/offline before schedule bid submission end date & time.

It is advised that all the Prospective Bidders shall register and obtain Udyam Registration Certificate. It may be noted that w.e.f. 1st April 2022, Udyam Registration Certificate shall be only valid Certificate to avail the benefits as per Public Procurement Policy.

MSEs seeking exemption and benefits should enclose an attested/self-certified copy of registration certificate as a part of his bid, giving details such as stores/services, validity (if applicable) etc. failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.

- 8. NTPC reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no Bidder / intending Bidder shall have any claim arising out of such action.
- 9. 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before

submission of their bids."

- 10. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
  - However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- 12. Issuance of Bidding Documents to any bidder shall not construe that such Bidder is considered to be qualified.
