7.0 Qualifying Requirements:

The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfil the following Technical Qualifying Requirements.

Technical Criteria

7.1.1 The bidder should have executed the work(s) for 'Operation Assistance/ Operation/ Operation & ma intenance/ Manpower assistance' in a Water Treatment Plant, for executed contract value of at least 212 Lakhs (Rupees two hundred and twelve lakhs) in one contract within preceding seven (07) years prior to the date of Techno-Commercial bid opening.

Notes for Technical Criteria:

- 1. The word "executed" means the bidder should have achieved the criteria specified above, even if the tot al contract is started earlier and/or is not completed/closed.
- 2. In case of order(s) under execution, the value of work executed prior to the date of Techno Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 3. Reference work executed by the bidder as a sub-contractor may also be considered provided the certific ate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

- 4. For arriving at the executed value of order specified at 7.1.1 above, basic amount (excluding GST) shall be considered. Consumable cost is also to be excluded if it is on reimbursement basis. In case of order/con tract is inclusive of taxes, agency has to provide the break -up of basic value (excluding tax and consumables if on reimbursement basis).
- 5. Reference works executed by the bidder, as a member of joint Venture / Consortium / Associate can also be considered provided:
 - 1. The allocation of scope of work between the partners of the joint Ventures / consortium/ Associate is clearly defined in the executed joint venture agreement I consortium agreement I dee d of joint undertaking and the bidder's scope of work and break-up of quantities executed by them as individual contribution in the joint Venture/ Consortium/ Associate, duly authenticated by the Pr oject Authority/Owner, meet the relevant provisions of eligibility criteria.
 - 2. In case the reference work has been executed by the bidder in an integrated joint venture wher ein allocation of scope of work and break-up of quantities between the partners is not clearly specified in the integrated joint venture Agreement, then for establishing the eligibility as per technical criteria of (Section of 7.1.1 of QR & SOW Operation of Chemistry related Plants and providing Sampling and Lab Analysis Services of NTPC-Barauni Stage-1 and Stage-2) the credit of executed quantities can be claimed by the bidder in the ratio of the bidder's share in the integrated joint Venture A greement, provided the bidder establishes that it regularly undertakes works mentioned in QR. The executed works/ quantities by the integrated joint venture shall be duly authenticated by the Project Authority/owner.

Financial Criteria

- 7.2.1 Average annual Turnover of the bidder in the preceding three (3) financial years as on the date of T echno-Commercial bid opening, shall not be less than Rs 265 Lakhs (Rupees two crore sixty-five lakhs only).
- 7.2.2 In case a bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 above on its own, its H olding Company would be required to meet the stipulated turnover requirements at Cl. 7.2.1 above, provid ed that the Net Worth of such Holding Company as on the last day of the preceding financial year is at lea st equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be requested to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the B id Documents, pledging unconditional & irrevocable financial support for the execution of the Contract by the Bidder in case of award
- 7.2.3 The Net Worth of the bidder shall not be less than 100% of the bidder's paid up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net Worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of its holding companies wherever applicable, the Net Worth of the Bidder and its Subsidiary(ies) and/or Holding Company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total p aid up share capital. However individually, their Net worth should not be less than 75% of their respective paid-up share capitals.

Net worth in combined manner shall be calculated as follows:

Net worth (combined) = (XI+X2+X3)I(YI+Y2+Y3)X100%

Where XI, X2, X3 are individual Net worth which should not be less than 75% of their respective paid-up sh are capitals and YI, Y2, Y3 are individual paid-up share capitals.

- 7.2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated A nnual Report of the company.
- 7.2.5 In cases where audited results for the last preceding financial year as on the date of Techno Comm ercial bid opening are not available, the financial results certified by a practicing Chartered Accountant sh all be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 7.2.0:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Compani es Act of India.
- 3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all res erves credited out of the profits and share premium account but does not include reserves credited out of t he revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit ba lance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if an y, shall be reduced from reserves and surplus.

- D) Further if any of the reference work submitted in the present tender, have already been su bmitted and verified/accepted by NTPC in earlier tender/s, details of NIT no, tender inviting authority etc of that earlier tender/s are to be filled up by the bidder in Attachment-3 of the present tender. The same may be accepted for the purpose of authenticity, subject to confir mations & fulfilment of qualifying requirement of the present tender.

- F) The physical or any mode of assessment/verifications by Employer shall include but not be limited to the assessment/verifications of office/ facilities/ banker's/ submitted reference wor ks in lieu of credentials. A negative determination of such assessment of credentials/capacity/ capabilities may result in rejection of the bid.
