**Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RfX and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on “Register” button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to “Create Response” and submit the bids against the Bid invitation into the system.
3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
  - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in

c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## QUALIFYING REQUIREMENTS

### NAME OF PACKAGE: PROCUREMENT OF INSTRUMENT AIR ROTORY SCREW TYPE COMPRESSOR FOR MAIN PLANT PP-2, NSPCL BHILAI.

The Bidders who wish to participate in the Bidding process shall meet the qualifying requirements stipulated here under:

#### **1.0 Technical Requirement:**

1.1 The bidder should be a manufacturer of oil free screw air compressor.

1.2 The bidder should have executed **Similar Order(s)** during the preceding 7 (Seven) years reckoned as on the date of technical bid opening in the following manner:

- a) Single Order of value not less than Rs. **73.32** Lakhs.  
OR
- b) Two Orders each of value not less than Rs. **45.82** Lakhs.  
OR
- c) Three Orders each of value not less than Rs. **36.66** Lakhs.

#### **2.0 Financial Requirement:**

**2.1.** The average annual turnover of the Bidder should not be less than Rs **91.65** Lakhs (Rupees Ninety-One Lakhs & Sixty-Five Thousand Rupees only) during the preceding three (03) financial years as on the first scheduled date of technical bid opening.

#### **Notes:**

- I.** The phrase “**similar order**” means:  
**The bidder should have supplied at least one no. of oil free screw air compressor along with dryer, each of capacity 750-850 CFM, at rated discharge pressure of 7.0-8.0 kg/cm<sup>2</sup> or above, which are in successful operation for at least two (2) years during the last 07 years as on the date of technical bid opening.**
- II.** Values as per clause 1.2 and 2.1 shall be considered inclusive of taxes & duties.
- III.** Other income shall not be considered for arriving at annual turnover.
- IV.** In case where audited results for the last financial year as on the date of technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO/Proprietor/Partners as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of technical bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.

5. NSPCL shall allow purchase preference, as indicated in the bidding documents, to bids from local suppliers as defined in the bidding documents. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
6. **Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).**
7. Notwithstanding anything stated above, the Employer reserves the right to undertake a physical assessment of the capacity and capabilities including financial capacity and capability of the Bidder / his Collaborator(s) / Associate(s) / Subsidiary(ies) / Group Company(ies) to perform the Contract, should the circumstances warrant such assessment in the overall interest of the Employer.

The physical assessment shall include but not be limited to the assessment of the office/facilities/banker's/reference works by the Employer. A negative determination of such assessment of capacity and capabilities may result in the rejection of the Bid.

The above right to undertake the physical assessment shall be applicable for the qualifying requirements stipulated above.

8. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
