3.1.1 The bidder should have executed work(s) for 'Operation Assistance' and /or Operation and/or 'Operation & maintenance' and /or Housekeeping and /or upkeeping and for 'Manpower assistance' in a coal based Thermal Power Plant for an executed value of a t least Rs. 395 lakhs (Rupees Three Ninety-five lakh) in a single contract, within preceding se ven (07) years prior to the date of Techno- Commercial bid opening. Notes for Technical Criteria: The word "Executed" mentioned above means that the bidder should have achieved the crite ria specified above, even if the total contract is started earlier and/or is not completed/closed In case of orders under execution, the value of work executed prior to the date of Techno-Co mmercial bid opening duly certified by bidder's client shall be considered acceptable. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the General Terms and Conditions/सामान्य नियम और शर्ते, conditions stipulated in Bid and

<u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
