6	Documents to be submitted in support of technical QR	<ol style="list-style-type: none"> a) Relevant PO copy of rewinding of at least five (05) nos. of HT (3.3kV min) motors under end-user or under 'PSU' or its Joint Venture Company / Govt. or Semi-Govt. department/power utilities during the last five (5) Years from the date of application for enlistment and Client's Completion Certificate/RA bill/Final Deviation Statement for the same. b) Certificates issued by Chartered account/ asset register etc. in support of In-house Facilities of electrical testing of HT motor at their works for carrying out during PDI.
7	Additional documents to be submitted	<p>In addition to the documents required in support of meeting technical requirements as stated above, following documents are required to be submitted by the Applicants applying for enlistment: -</p> <ol style="list-style-type: none"> a) Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/ final deviation statement from the concerned client in support of successful execution of jobs against each of the POs to be submitted. b) Audited balance sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered accountant may be submitted. c) NSIC / SSI / MSME/ESIC registration certificate (if applicable) d) PF and Service Tax registration certificate e) Any other documents in addition to the above which the applicant wants to submit
8	Notes	<ol style="list-style-type: none"> a) Similar work means: Rewinding of HT Motors of 3.3 KV or above rating during last 5 years under end-user or under 'PSU' or its Joint Venture Company / Govt. or Semi-Govt. department. b) Value means basic value (excluding taxes) of the P.O. pertaining to executed similar work as mentioned vide Note-1 above. Where P.O. value is composite, the applicant should have to give break-up of Composite PO value mentioning Basic Value, taxes etc.
