Audited balance sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered accountant may be submitted. 3. NSIC / SSI / MSME registration certificate, if applicable 4. PF and Service Tax registration certificate 5. Any other documents in addition to the above which the applicant wants to submit. |
