Scope of Work:

- 1. Scope of work include cutting of grass/jungle/elephant grass and bushes at following locations including their disposal at location specified by EIC as per BOQ. However, work may be executed at outside plant near gate complex, or any other area as instructed by EIC.
- 2. All required manpower, tools and tackles etc are in the scope of contractor. The contractor has to mobilize all the resources as per requirement so that work can be completed within the schedule time as per satisfaction of EIC.
- 3. Safety shall be foremost and the agency must ensure all required PPEs (Safety Shoe, Helmet, gum boots, glove etc) to all workers.
- 4. All arrangements for dwelling facilities of workmen to be provided by agency.

- 11. PF @ 13% (I/c admn charges) of basic minimum wage.
- 12. Bonus @ 8.33% of basic minimum wage.
- 13. Positive deviation in contract will not be admissible.
