# 6.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder :

## 6.1.0 QUALIFYING REQUIREMENTS:

#### 6.1.1 : Technical Criteria:

The bidder should have executed work(s) which includes **Erection/ Installation of** equipment(s) of ash handling system within preceding 07 (seven) years prior to the date of Techno- commercial bid opening in any of the following manner :

(a) Executed value not less than **Rs. 170 Lakhs** in a Single Contract.

OR

(b) Executed value not less than **Rs. 106 Lakhs** in Two Contracts each.

OR

(c) Executed value not less than Rs. 85 Lakhs in Three Contracts each.

## Notes for Technical Criteria:

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed / closed.

2. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner.

3. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.

4. For arriving at the executed value of work specified above, basic amount only shall be considered. In case of contract is inclusive of taxes, bidder should provide the break —up of basic value and taxes.

5. Equipment(s) of ash handling system means Vent fan and/or Bag filter assembly and/or Vent Filter assembly and/or Ash conditioner (or HMDC) and/or Rotary vane feeder and/or telescopic chute and/or Cooling water pump and/or Instrument air compressor and/or Transport air compressor and/or erection of Ash conditioner pump(s) (or HMDC pump) and/or cast iron pipe lines and/or Knife gate valves and/or Buffer hopper(s) and/or D pump(s) and/or air lock vessel(sand/or ash silo(s).

#### 6.1.2 FINANCIAL CRITERIA:

**6.1.2.1** The Average Annual Turnover of the Bidder, should not be less than **Rs 212 Lakh** (Rupees Two Crore twelve lakh only) during the preceding three (3) completed financial years prior to the date of Techno-Commercial bid opening.

- **6.1.2.2** In case the bidder does not satisfy the financial criteria, stipulated at Cl. 6.2.1 above on its own, its holding company would be required to meet the stipulated turnover requirements at Cl. 6.2.1 above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the holding company, supported by Board Resolution of the holding company, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- **6.1.2.3** In case the bidder is not able to furnish its audited financial statements on stand- alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
  - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
  - A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the Holding Company.
- **6.1.2.4** In cases where audited results for the last preceding financial year as on the date of techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Certificate from the gracticing Chartered Accountant certifying the financial parameters is not available.

#### Notes for 6.1.2

1. Other income shall not be considered for arriving at annual turnover.

2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.

3. Net worth means the sum total of the paid up share capital and free reserves Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

**7.0** 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

Bidders are requested to give acceptance of being Class-I Local Supplier (Minimum Local Content equal to or more than 50%) by accepting the GTE & declaration in Bid Form.

By accepting the MLC provision of GTE it will be considered that :-

"Bidder is 'Class-I local supplier' and is meeting the MLC requirement stipulated in Annexure-II to BDS.

**8.0** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
