Any individual prospective **PAP**/ **Non PAP of Chatti Bariatu Coal Mining Projects** are hereby requested to submit their Expression of Interest (EOI) for deployment of new vehicle in the enclosed prescribed format within given time period. It may please be noted that only one vehicle will be hired from one individual PAP / Non PAP.

Further, it is expected that the applicants have gone through the detailed terms and conditions of the proposed contract. Copy of the same is attached for your reference.

EOI along with requisite formats and land details, family tree, copy of payment notice/payment receipt etc in support of their claim of being a PAP/ landoustee and other documents as mentioned in the terms and conditions shall be submitted online at <u>https://eprocurentpc.nic.in</u> on or before the last date and time mentioned above.

All applications received by the due date and time will be verified by NTPC in line with qualifying requirements as mentioned below. Thereafter, a priority list will be prepared on the basis of criteria for preparing priority list as mentioned below:

### 1.0 QUALIFYING REQUIREMENT FOR DEPLOYMENT OF VEHICLES

- i. The applicant shall be required to deploy brand new bolero / Scorpio having taxi/commercial registration.
- ii. The applicant would **purchase new vehicle** and deploy within 21 days of issue of Letter of Intent may also submit their application with an undertaking to purchase new vehicle.
- iii. The applicant for PAP category must be a PAP of Coal Mining projects, Hazaribagh. Relevant document regarding same needs to be enclosed along with application.
- iv. Applicant should submit copy of PAN card or acknowledgment of application for PAN card. However, the copy of PAN card must be submitted before placement of award letter. Copy of Aadhar card shall also to be submitted.
- v. The applicant should have GST registration. However, small service providers who are not coming under the purview of GST may also submit their bid on self certification (in the form of a notarized affidavit) that they are exempted from GST.

As per our Qualifying Requirements mentioned above, all EOIs will be examined to find out technically qualified EOIs. Priority will be given for hiring of the required vehicle on following sequence:

- i. (Land + Homestead) oustees assumed as Category-A would be considered at I<sup>st</sup> priority (weightage on the basis of acreage of land acquired).
- ii. Homestead oustees assumed as Category-B would be considered at II <sup>nd</sup> priority and
- iii. Land oustees assumed as Category-C would be considered at III <sup>rd</sup> priority (weightage on the basis of acreage of land acquired).
- iv. Vehicle applicants who are not engaged through direct / indirect employment by the project / station will be preferred for the deployment of vehicle, subject to above priority.
- v. However if PAP falls in same category, the preference shall be as per the date of birth of vehicle owner according to PAN/DL/Aadhar card/10th certificate. Older date of birth (oldest owner) shall be given first preference. The applicants who are already engaged in running contract, their names shall be considered for award of any contract against subject empanelment only after expiry of the existing running contract.
- vi. If the numbers of eligible applicants meeting the NIT requirements are more than the number of vehicles required, then the balance applicants shall be empaneled for three years from the date of approval of empanelment, to meet any future requirement of the vehicle at Stations/Projects. If required, NTPC may extend the validity of the period of empanelment.
- vii. The PAP who has been awarded a contract for hiring vehicle shall be given least priority irrespective of category for consecutive contract of vehicle hiring.
- viii. In case of taken-over projects, the vehicle-hiring contract shall be awarded on basis of NTPC's Works & Procurement Policy

Enlistment of PAP applicant of other nearby NTPC projects will be considered only after exhaustion of PAP applicants of Chatti Bariatu CMP. PAP applicants of KDCMP will be given 2<sup>nd</sup> priority and PAP applicants of PBCMP shall be given 3<sup>rd</sup> Priority.

Further Enlistment of Non PAP will be considered only after exhaustion of PAP applicants. Among Non PAP applicants nearest to CB Mine area will be given I<sup>st</sup> priority.

## 2.0 Brief Terms and Conditions of Hiring are mentioned below:

- Vehicle variant: 5 Door Hard top
- Model: Mahindra Bolero/ Bolero Neo / Scorpio / Scorpio N
- Vehicle should possess COMMERCIAL REGISTRATION.

• Hiring charge per month: Rs.34000/- excl GST for Bolero & Rs.38000/- excl GST for Scorpio.

• The agency shall also be reimbursed fuel @12km per litre (for Bolero) and @10Km per litre (for Scorpio).

• All other terms and condition of contract shall be as per detailed terms and conditions for the above work and as per NTPC GCC for Civil works.

3.0 In case any applicant on issuance of LOI/PO fails to deploy the vehicle within the specified time period, the next applicant in the priority list shall be considered for deployment of vehicle. The applicant who has failed to deploy the vehicle shall be considered in the last after exhaustion of all the remaining applicant in the priority list.
