- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Scope of Supply

Brief Scope of Work:

Procurement of 6 no. of ASH BAGGING MACHINE, 201-400BAG/HR for filling FOR FILLING OF ASH IN STANDARD VALVE BAGS OF 50 KG.

1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Re quirements stipulated hereunder:

1.1 Technical Criteria:

- **1.1.1** The bidder should be a manufacturer for 'Bagging Machine'.
- **1.1.2** The bidder should have executed orders for supply of 'Bagging Machine(s) and/or its spares' to any 'Power Plant/Cement Industry', in the preceding seve n (7) years prior to the date of techno commercial bid opening in any of the foll owing manner:
- 1. Single executed order of value not less than Rs. 42 Lakhs.

OR

2. Two executed orders of value not less than Rs. 26 Lakhs each.

OR

3. Three executed orders of value not less than Rs. 21 Lakhs each.

Notes for Technical Criteria:

- 1. The word "Executed" mentioned above means that the bidder should have achi eved the criteria specified above, even if the total order is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of the order executed prior to the d ate of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 3. For arriving at the executed value of order specified above, basic amount only shall be considered. In case order is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. Latest annual report OR NSIC / SSI / MSME registration certificate / BIS license / ISO certificate / MDCC/ any other statutory document as a proof of being manuf acturer of the required material.

1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs 53**Lakh (Rupees Fifty-three lakh only) during the preceding three (3) com pleted financial years prior to the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.
 2.1 above on its own, its Holding Company would be required to meet the sti pulated turnover requirements at Cl. 1.2.1 above, provided that the net wort h of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid do cuments, pledging unconditional and irrevocable financial support for the ex

ecution of the Contract by the bidder in case of award.

- 1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furni shes the following documents for substantiation of its qualification.
- (a) Copies of the unaudited unconsolidated financial statements of the bidder alon g with copies of the Audited consolidated financial statements of its Holding Company.
- (b) A Certificate from the CEO/CFO of the Holding Company, as per the format encl osed in the bidding documents, stating that the unaudited unconsolidated finan cial statements form part of the Consolidated Annual Report of the company.
 - 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 1.2:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribe d to them as per Companies Act of India, in vogue.
- 3. Net worth means the sum total of the paid-up share capital and free reserves. F ree reserve means all reserves credited out of the profits and share premium ac

count but does not include reserves credited out of the revaluation of the assets , write back of depreciation provision and amalgamation. Further, any debit bala nce of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
