- 1. - 2.0 BRIEF SCOPE OF WORK

The scope of the proposal is supply of "Screen Plate & Kick off P late for Crushers Stage I & II in CHP, NTPC-Korba" and shall be on the basis of single point responsibility completely covering the activities and services covered under the specifications and read in conjunction with "Scope of Supply" elaborated elsewhere.

5.3 In case of Bidders opting for Bank Guarantee as Bid Security but unable to submit the Original Bank Guarantee in physical form at the tender opening location, be fore the deadline for submission of bids, following shall also be considered acceptable, subject to para 5.4 below:

The issuing bank shall intimate through their own official email id to concerned C&M department with a copy to B idder regarding issuance / extension of Bank Guarantee (B G) along with following documents, before the deadline of su bmission of bids:

b) SFMS / SWIFT message acknowledgement copy sent to NT PC / Employer's banker stating the date of sending.

5.4 The bidder shall be required to submit all the docum ents in the manner as specified at para 5.3 above, to reac h NTPC/Employer before the deadline for submission of bids , failing which its bid shall be rejected as being non-res ponsive and not opened. In such a case, Bidder shall also be required to submit the Original BG in physical form t o reach NTPC at the address mentioned in Bidding Document s, not later than 10 days from the date of submission of Tech no-Commercial bids or before the Price Bid opening, whichev er is earlier, failing which its bid shall be rejected and not con sidered for further evaluation.

5.5 Micro and Small Enterprises (MSEs) shall be exempted from payment of EMD. MSEs seeking exemption should upl oad/enclose a copy of Udyam Registration Certificate as a p art of their bid failing which they run the risk of their bid be ing passed over as ineligible for the benefits applicable to MSE's

5.6 Benefits for MSEs as elaborated at para 5.5 above are applicable only for (a) Goods produced and (b) Service s provided by MSEs. MSE benefits shall not be applicable to Trader/Dealer of Goods.
