- I. NTPC invites on-line bids on Single Stage Two Envelope Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders for aforementioned package as per Scope of Work mentioned hereinafter.
- **II.** Brief Scope of Work:

The work includes the packing, loading, transportation, unloading and erection of boards (display) at various locations of Talaipalli Coal Mining Project, Raikera, Ghargoda, Raigarh district, Chhattisgarh. It also includes arranging the manpower to complete the installation work including all the civil works required along with the required materials and machineries. The installations and location of installation sites will be as per the directives of Engineer-in-Charge.

IV. Bidder may submit EMD through E-Payment by Credit Card/Debit card/Net Banking on the NTPC e-tender portal. In case Tender Fee and EMD is not submitted through E payment then Bidder has to furnish the same in a sealed envelope separately offline along with other documents mentioned in the tender documents by the stipulated bid submission closing date and time at the address given below in accordance with the provisions set forth in the bidding documents, failing which, online bid shall be treated as non-responsive and shall not be opened.

V. Qualifying Requirements for Bidders: NA

However, the bidder should have executed work of Fabrication, Supply and Installation of safety boards or similar nature works, within the preceding seven (07) years reckoned as on the date of Techno- Commercial Bid Opening with either of following.

- (a) Single order with executed value not less than Rs. 13 Lakh
- (b) Two orders with executed value not less than Rs. 20 Lakh
- (c) Three orders with executed value not less than Rs. 26 Lakh

Note for above:

- 1. The word "executed" means the bidder should have achieved the criteria including the value as mentioned above during last seven (7) years as on date of Techno-Commercial bid opening period even if the contract has been started earlier and / or is not completed / closed.
- 2. Necessary documentary evidence in support of execution of the work including the value specified above to be submitted for qualification.
- VA. Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).

- VI. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
- **VII.** The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the NTPC tender website https://gem.gov.in.
- **VIII.** Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified.
- **IX.** Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- X. 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- XI. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
