1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- **1.** Bids not accompanied by requisite EMD as per clause 5.0 of SPC (Special Purchase Conditions) shall be outrightly rejected.
- 2. Bidder may refer ITB (Instruction to bidder) clause 15.0 for Advisory Bank details for BG confirmations.
- **3.**Bidder should submit the scope of work document duly signed and stamped with their company's seal /s tamp as token of acceptance to the total scope of work of the bid.
- **4.**Bidder has to mandatorily fill the Annexure-12 (QR summary sheet) in support of reference documents f or meeting QR and upload the same along with the technical bid in Technical Cover. (**Refer ITB clause 26 for more details**).
- 5. Bidder has to consider all the statutory compliances regarding minimum wages to the manpower deploy ed. Pradhan Mantri Jeevan Jyoti Bima Yojna & Pradhan Mantri Suraksha Bima Yojna should also be conside red while quoting rates. The wages paid against the hike in wages on account of changes in the wages as per the guidelines of Ministry Of Labour Ministry shall be passed on to the respective employed manpower.
- **6.** Bidder must submit the excel price breakup along with the PRICE BID only.
- 7. The Techno-Commercial Bid should not contain any price content entry. In case, the Techno-Commercial Bid is found to contain any price content, such bid shall be liable for rejection.

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
