# **Qualifying Requirements.**

### 1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Re quirements stipulated hereunder:

### 1.1 Technical Criteria:

**1.1.1** The bidder should have executed work (s) of 'Operation/Operation & Maintenance /Operation Assistance' of a Coal Handling Plant including field equipment(s)/system & auxiliaries' Feeding coal to a Thermal Power Station having minimum capacity of 200 MW, for a minimum continuous period of one year within preceding seven (07) years prior to the date of techno-commercial bid opening.

### **Notes for Technical Criteria:**

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria sp ecified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

- 3. **Field Equipment(s)** /systems & auxiliaries means 'Stacker Reclaimer/Wagon-Tippler/Side Ar m Charger/Paddle Feeder/Travelling Tripper/Tripper.
- 4. Reference works executed by the bidder, as a member of joint Venture / Consortium / Associate c an also be considered provided:
  - (a) The allocation of scope of work between the partners of the joint Ventures / consortium / Associ ate is clearly defined in the executed joint venture agreement / consortium agreement / deed of joi nt undertaking and the bidder's scope of work and break-up of quantities executed by them as indi vidual contribution in the joint Venture / Consortium / Associate, duly authenticated by the Project Authority/Owner, meet the relevant provisions of eligibility criteria.
  - (b) In case the reference work has been executed by the bidder in an integrated joint venture whe rein allocation of scope of work and break-up of quantities between the partners is not clearly speci fied in the integrated joint venture Agreement, then for establishing the eligibility as per technical c riteria 1.1.1 of QR, the credit of executed quantities can be claimed by the bidder in the ratio of bi dder's share in the integrated joint Venture Agreement, provided the applicant establishes that it r egularly undertakes works mentioned in QR. The executed works/ quantities by the integrated join t venture shall be duly authenticated by the Project Authority/owner."

### 1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs 66
  1 Lakh (Rupees Six Crore Sixty-One lakh only) during the preceding thr ee (3) completed financial years prior to the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1. 2.1 above on its own, its Holding Company would be required to meet the sti pulated turnover requirements at Cl. 1.2.1 above, provided that the net wort h of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid do cuments, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 1.2.3 The Net Worth of the bidder shall not be less than 100% of the bidder's pa id-up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net Worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of its holding companies w herever applicable, the Net Worth of the Bidder and its Subsidiary(ies) and/or H

olding Company and/or Subsidiary(ies) of the Holding Company, in combined m anner should not be less than 100% of their total paid up share capital. Howeve r individually, their Net worth should not be less than 75% of their respective paid-up share capitals.

Net worth in combined manner shall be calculated as follows:

Net worth (combined) = (X1+X2+X3) / (Y1+Y2+Y3) X 100%

Where X1, X2, X3 are individual Net worth which should not be less than 75% of their respective paid-up share capitals and Y1, Y2, Y3 are individual paid-up share capitals.

- 1.2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
  - a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
  - b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidd ing documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 1.2.5 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### Notes for 1.2

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- 3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve me ans all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and ama Igamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
