- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

# Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Buyer Added Bid Specific ATC

## 1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Re quirements stipulated hereunder:

#### 1.1 Technical Criteria:

**1.1.1** The bidder should have executed the order(s) for supply of Bottom Cones ep(s) within preceding 07 (seven) years prior to the date of Techno- commercial bid opening in any of the following manner:

A. One (1) order having executed value not less than Rs. 165 Lakhs (Rupees On e Hundred Sixty five Lakhs Only).

OR

B. Two (2) orders having executed value not less than Rs. 103 Lakhs (Rupees one Hundred Three Lakhs Only) each.

OR

C. Three (3) orders having executed value not less than Rs. 82 Lakhs (Rupees Eighty Two Lakhs Only) each.

## **Notes for Technical Criteria:**

- 1. The word "Executed" mentioned above means that the bidder should hav e achieved the criteria specified above, even if the total order is started e arlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of the order executed prior t o the date of Techno-Commercial bid opening duly certified by bidder's cli ent shall be considered acceptable.
- 3. For arriving at the executed value of order specified above, basic amount only shall be considered. In case order is inclusive of taxes, bidder should provide the break up of basic value and taxes.

## 2.0 Financial Criteria:

- 2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. 206 Lakhs (Rupees Two crore and Six Lakhs Only) during the preceding thr ee (3) completed financial years as on the date of Techno-Commercial bid o pening.
- 2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2. 1 above on its own, its Holding Company would be required to meet the stipulat ed turnover requirements at Cl. 1.2.1 above, provided that the net worth of suc h Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commer cial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditi onal and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- .2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furni shes the following documents for substantiation of its qualification. Copies of the unaudited unconsolidated financial statements of the bidder along with c opies of the Audited consolidated financial statements of its Holding Company. A Certificate from the CEO/CFO of the Holding Company, as per the form at enclosed in the bidding documents, stating that the unaudited unconsolid ated financial statements form part of the Consolidated Annual Report of the

company.

.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

## Notes for 1.2:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning as cribed to them as per Companies Act of India, in vogue.
- 3. Net worth means the sum total of the paid-up share capital and free reser ves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revalu ation of the assets, write back of depreciation provision and amalgamatio n. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- **3.0** (a) . NTPC reserves the right to reject any or all bids or cancel / withdraw th e Invitation for Bids/NIT without assigning any reason whatsoever and in such c ase no bidder / intending bidder shall have any claim arising out of such action.
- b. Issuance of bid documents to any Bidder shall not construe that such bidder i s considered to be qualified.

NOTE: The Bidder's attention is also drawn that only the reference Works/ Orders whose details have been declared in their Bid, shall be considered to ascertain the bidder's compliance to the specified Qualifying Requirements (QR). No new supply order should be asked for so as to qualify the bidder.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
