**1.0** NTPC Renewable Energy Limited (NTPC REL) invites online bids on Single Stage **Composite Bidding** basis from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

**2.0 Brief Scope of Work:**

The brief scope of work comprises of

- a. **Deployment of one (01) Air-Conditioned Vehicle Mahindra Bolero / Mahindra Bolero Neo or equivalent model or Higher model like Mahindra Scorpio / Tata Harrier etc (Not earlier than 2022 Make) with necessary safety features for 12 Hrs per day including driver etc all complete.**
- b. **Scope of services under this contract shall cover deployment of Rajasthan Registered Taxies as per specifications given on hire basis for use in NTPC REL, Chhattargarh Solar PV Project, Rajasthan.**
- c. **The vehicle shall be required for various visits at Plant & Other City of Rajasthan as per requirement and should run on DIESEL fuel, having necessary safety features, and shall be commercially registered on Rajasthan State. The vehicle to be deployed shall be in good condition.**

NTPC REL intends to finance subject Package through Internal Resources.

**5.0** 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

**6.0** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

**7.0** NTPC REL reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.

**8.0** Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
