A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form pa rt of the Consolidated Annual Report of the company. 3.2.4 In cases where audited results for the last preceding financial year as on the date of Te chno-Commercial bid opening are not available, the financial results certified by a practici ng Chartered Accountant shall be considered acceptable. In case, Bidder is not able to subm it the Certificate from practicing Chartered Accountant certifying its financial parameters, the a udited results of three consecutive financial years preceding the last financial year shall be con sidered for evaluating the financial parameters. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
