1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other

than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Qualifying Requirements (QR)

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated her eunder:

1.0 Technical Criteria:

1.1 Route-1

The bidder should be a Manufacturer / Supplier of Turbine Condenser for Power Plants and should have Su pplied at least one (01) number Main Turbine Condenser for Unit Capacity of minimum 100 MW, which should have been in operation for at least one (1) year, prior to the date of techno-commercial bid opening.

1.2 Route-2

1.2.1 Bidder should have manufactured and Supplied Cu- Nickel Tube for Main Turbine Condenser for Pow er Plants of Unit Capacity of minimum 100 MW, prior to the date of techno commercial bid opening.

AND

- **1.2.2** The bidder should have supplied 'Cu-Ni tubes/pipes' to any industry within preceding seven (07) ye ars prior to the date of Techno-Commercial bid opening, in any of the following manner:
- A. One (1) order having executed value not less than Rs. 985 Lakh

OR

B. Two (2) orders having executed value not less than Rs. 616 Lakh each

OR

C. Three (3) orders having executed value not less than Rs. 493 Lakh each

Notes for Clause 1.0 above (Technical Criteria):

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Techno- Commercial b id opening duly certified by bidder's client shall be considered acceptable.
- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. For the purpose of submission of documentary evidence in support that the Bidder is a manufacturer (a s per sl. 1.1 or 1.2), the bidder will submit NSIC / SSI / MSME registration certificate / BIS license / ISO certificate / any other document as a proof of being manufacturer as per QR.
- 5. In case of any executed value submitted by the bidder is in foreign currency, Bill Selling Exchange Rate established by State Bank of India as on the date of Techno-Commercial bid opening shall be used.

2.0 Financial Criteria:

2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 1232 Lakh (Rupees Twelv e Crore & Thirty Two lakhs only)** during the preceding three (3) completed financial years as on the da te of Techno-Commercial bid opening.

- **2.2** In case the bidder does not satisfy the financial criteria, stipulated at Cl. 2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 2.1 above, provided th at the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging uncondition all and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- **2.3** In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
- **i.** Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audit ed consolidated financial statements of its Holding Company.
- **ii.** A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding docu ments, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annu al Report of the company.
- **2.4** In cases where audited results for the last preceding financial year as on the date of Techno- Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 2.0:

- i. Other income shall not be considered for arriving at annual turnover.
- **ii.** "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- **iii.** Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all r eserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit be alance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if a ny, shall be reduced from reserves and surplus.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
