Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/ final deviation statement from the concerned client in support of successful execution of jobs against each of the POs to be submitted.</li> <li>2. Audited balance sheet including Profit &amp; Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered accountant may be submitted.</li> <li>3. NSIC / SSI / MSE registration certificate, if applicable.</li> <li>4. PF and Service Tax registration certificate.</li> <li>5. Any other documents in addition to the above which the applicant wants to submit.</li> </ol>

Similar work means:</b> Conveyor belt jointing and its associated jobs, in "Coal handling / Material handling system" of "Thermal Power Station / Coal Mine / Iron and Steel Industries / Aluminium Plant / Cement Plant / Any Other Industry</p> <p><b>NOTE:</b> In case of any composite PO which includes conveyor belt jointing jobs in addition to other mechanical maintenance / overhauling /erection jobs in "Coal handling / Material handling system" of "Thermal Power Station / Coal Mine / Iron and Steel Industries / Aluminium Plant / Cement Plant / Any Other Industry the overall executed value of the PO excluding material supply, if any, shall be considered as executed value for calculation of EC.</p> <p><b>Remarks:</b></p> <ol style="list-style-type: none"> <li>(i) Full executed value of Composite POs considered since it is not possible to calculate value of job carried out for only conveyor belt jointing and associated jobs in absence of BOQ (Lumpsum Contracts).</li> <li>(ii) Some of the organisations now a days are awarding composite contracts area wise like CHP, Boiler, TG &amp; BOP, Electrical &amp; C&amp;I etc. Hence those contractors are not able to submit itemwise execution details.</li> </ol>
