1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - **3.**Bidder should submit the scope of work document duly signed and stamped with their company's seal /s tamp as token of acceptance to the total scope of work of the bid.
- **4.**Bidder has to mandatorily fill the Annexure-12 (QR summary sheet) in support of reference documents f or meeting QR and upload the same along with the technical bid in Technical Cover. (Refer ITB clause 26 fo r more details).
- **5.** The Techno-Commercial Bid should not contain any price content entry. In case, the Techno-Commercial Bid is found to contain any price content, such bid shall be liable for rejection.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
