SCOPE OF WORK, TERMS & CONDITIONS

Internet Bandwidth: One 100Mbps Internet link at NTECL site office. In case of any signal loss and if requir ement arise for any amplifier, FOD at service building end and site office end, same shall be provided by t he contractor.

Installation and Scope of Work: Supply and installation of all the equipment and necessary associated acce ssories are in the scope of contractor. It is not the intent or purpose of this scope of work to cover each an d every part of the services required for completeness. It shall be the responsibility of the contractor to off er all the equipment and services, whether specified or not which are required for installation, commissioning and maintaining high availability of the Internet services.

Deliverables: MUX /MODEM to be installed at NTECL's site office. The Internet to be provided on Ethernet port with 5Nos of Public IPs. Escalation matrix with contact no. and email ID for reporting complaints.

Response Time: In case of Internet link failure, problem has to be identified within 6 hours of complaint reported and link to be restored within 24 hours.

Availability: As per GEM Service Level Agreeement. The contractor shall submit availability report on quart erly with parameter bandwidth utilization, packet loss, latency.

Liquidate Damage: As per Cl No. 8 of GEM Service Level Agreeement.

Payment Terms: Payment shall be released on quarterly basis on submission of availability report and cert ification of engineer in charge.

Start date: 01.11.2023

Contract Period: The Contract period is 2 (Two) years from the date of start

Security Deposit(SD): 10% of Contract value. SD shall be deducted from the progressive runing bills @10%

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
