3. A copy of EMD/Bid security shall be uploaded in the technical bid folder, on GeM and hard copy of same shall reach to our office within 5 days of opening of technical bid.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
