3.1	TECHNICAL CRITERIA:	

The bidder should have executed work(s) for 'Operation Assistance / Operation / Operation & maintenance/ Housekeeping / Upkeeping / Manpower assistance' in a Coal-based Thermal Power Plant, for an executed value of at least Rs. 409 lakh (Rupees Four Crore Nine lakh) in a single contract within preceding 07 (seven) years prior to date of Techno-Commercial bid opening.

NOTES for 3.1:

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criterial specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Tech no-Commercial bid opening duly certified by bidder's client shall be considered accept able
- 3. Reference work executed by the bidder as a sub-contractor may also be considered pr ovided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.
- 4. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 5. Reference works executed by the bidder, as a member of joint Venture / Consortium / Associate can also be considered provided:
- a) The allocation of scope of work between the partners of the joint Ventures / consortium m / Associate is clearly defined in the executed joint venture agreement / consortium agreement / deed of joint undertaking and the bidder's scope of work and break-up of quantities executed by them as individual contribution in the joint Venture / Consortium / Associate, duly authenticated by the Project Authority/Owner, meet the relevant provisions of eligibility criteria.
- b) In case the reference work has been executed by the bidder in an integrated joint ven ture wherein allocation of scope of work and break-up of quantities between the partne rs is not clearly specified in the integrated joint venture Agreement, then for establishing the eligibility as per technical criteria 1.1.1 of QR, the credit of executed quantities can be claimed by the bidder in the ratio of bidder's share in the integrated joint Venture Agreement, provided the applicant establishes that it regularly undertakes works mentioned in QR. 3.2 FINANCIAL CRITERIA:

3.2.1) The Average Annual Turnover of the Bidder, should not be less than Rs 511 Lakh (Rupees Five Crore Eleven lakh only) during the preceding three (3) completed financi

al years as on the date of Techno-Commercial bid opening.

3.2.2) In case the bidder does not satisfy the financial criteria, stipulated at Cl. 3.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 3.2.1 above, provided that the net worth of such Holding Company as on the last da

y of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with i ts Techno- Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of a ward.

- **3.2.3)** The Net Worth of the bidder shall not be less than 100% of the bidder's paid up sha re capital as on the last day of the preceding financial year. In case the Bidder meets the r equirement of Net Worth based on the strength of its Subsidiary(ies) and/or Holding Compa ny and/or Subsidiaries of its holding companies wherever applicable, the Net Worth of the B idder and its Subsidiary(ies) and/or Holding Company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total paid up share ca pital. However individually, their Net worth should not be less than 75% of their respective p aid-up share capitals. Net worth in combined manner shall be calculated as follows:

- **3.2.4)** In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
 - a) Copies of the unaudited unconsolidated financial statements of the bidder along wit h copies of the Audited consolidated financial statements of its Holding Company.
 - b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial state ments form part of the Consolidated Annual Report of the company.

3.2.5) In cases where audited results for the last preceding financial year as on the date of T echno-Commercial bid opening are not available, the financial results certified by a practicin g Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

NOTES for 3.2:

1. Other income shall not be considered for arriving at annual turnover.

2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to the m as per Companies Act of India, in vogue.

3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserv

e means all reserves credited out of the profits and share premium account but does not i nclude reserves credited out of the revaluation of the assets, write back of depreciation p rovision and amalgamation. Further, any debit balance of Profit and Loss account and mis cellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
