Also, the bidder must have conducted at least 01 (o ne) Electrical Safety Audit for an open cast mine in the preceding 07 (seven) ye ars as on the date of techno-commercial bid opening.

Necessary documents in this regard shall be attached with the bid.

NTPC Bidding Document shall prevail over GeM ATC & STC in case of co nflict of any provisions.

Security Deposit shall be 10% of Award Value.

Bidders submitting their bids shall be deemed to have accepted all ten der conditions without any deviation.
