- 1.1 The Bidder should have executed the wo rk(s) of Deployment of "Nursing Staff/ Pa ramedical Staff / Doctors / Technicians re lated to Health Services" for at least one year in single order within the preceding seven (7) years prior to the date of Tech no-Commercial bid opening.
- 1.2 The bidder should have executed the wo rk(s) of "Deployment of manpower" with in the preceding seven (7) years prior to the date of Techno-Commercial bid opening, in any of the following manner:
- a. One(1) order having executed value not I ess than Rs. 104 lakh

Notes for Clause 1.0 above:

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.

- 2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 3. Reference work executed by the bidder a s a sub-contractor may also be considered provided the certificate issued by main con tractor is duly certified by owner specifying the scope of work executed by the sub-cont ractor in support of qualifying requirement s.
- 4. For arriving at the executed value of wor k specified above, basic amount only shall b e considered. In case contract is inclusive o f taxes, bidder should provide the break u p of basic value and taxes.

2.0 FINANCIAL CRITERIA:

- 2.1 The Average Annual Financial Turnover (AATO) of the bidder during preceding thre e (03) consecutive financial years as on the date of Techno Commercial bid opening should not be less than Rs. 131 Lakh (Rupees One Crore thirty-one lakh only).
- 2.2 In case the Bidder does not satisfy the f inancial criteria, stipulated at Cl. No. 2.1 ab ove on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. No. 2.1 above, provided that the Net Worth of such Holding Compan

y as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Bid Documents, pledging unconditional & irrevocable financial support for the execution of the contract by the bidder in case of award.

- 2.3 In case the bidder is not able to furnish its audited financial statements on stand-al one entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:
 - Copies of the unaudited unconsolidate d financial statements of the bidder alo ng with copies of the audited consolida ted financial statements of the Holding Company.
 - A certificate from the CEO/CFO of the Holding Company, as per the format en closed in the bidding documents, stating that the unaudited unconsolidated f inancial statements form part of the Consolidated Annual Financial Statements of the Holding Company.
- 2.4 In cases where audited results for the last financial year as on the date of Techno commercial bid opening are not available, t

he financial results certified by a practicing Chartered Accountant shall be considered a cceptable. In case, Bidder is not able to sub mit the certificate from practicing Chartere d Accountant certifying its financial parame ters, the audited results for the three (03) c onsecutive financial years preceding the las t financial year shall be considered for eval uating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding d ocument stating that the financial results o f the company are under audit as on the dat e of Techno-commercial bid opening and th e certificate from the practicing Chartered accountant certifying financial parameters i s not available.

3.0 Notes for Clause 2.0 above:

- 1. Net worth means the sum total of the pai d-up share capital and free reserves. Free r eserve means all reserves credited out of t he profits and share premium account but d oes not include reserves credited out of the revaluation of the assets, write back of dep reciation provision and amalgamation. Furt her any debit balance of Profit and Loss account and miscellaneous expenses to the ext ent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- 2. Other income shall not be considered for arriving at annual turnover figures.
- 3. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed

to them as per Companies Act of India.
