- 1.0** NTPC Limited (A Government of India Enterprise) intends to set up Stage-II of Lara Project comprising of 2 units of 800MW Coal based Power Project. These new units are proposed to be located adjacent to the existing Lara STPP Stage-I, Tehsil Pussore in Raigarh Distt. of Chhattisgarh.
- 2.0 Location and Approach**
The project is located in Raigarh District of Chattisgarh State. The project is located in South-east of Raigarh town near village Lara Tehsil Pussore, bounded by Villages Lara, Chhapora & Lohakhan and on the western side of Odisha boundary.
