1.1.1 The bidder should have executed wor k(s) for 'Operation Assistance /Operation / Operation & maintenance/ Housekeeping / Upkeeping /Manpower assistance' in a Coal Based Thermal Power Plant, for an execute d value of at least Rs. 333 lakhs (Rupees Th ree crore thirty-three lakh) in a single contract within preceding 07 (seven) years prior to date of Techno-Commercial bid opening.

NOTES:

1 The word "Executed" mentioned above means that the b idder should have achieved the criteria specified above, ev en if the total contract is started earlier and/or is not comp leted/closed.

2 In case of orders under execution, the value of work executed prior to the date of

Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.

3 Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

4 For arriving at the executed value of work specified abov e, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break – up of basic value and taxes.

- 5 "Reference works executed by the bidder, as a member of joint Venture /Consortium / Associate can also be considered provided:

1.2 FINANCIAL CRITERIA:

- 1.2.1 The Average Annual Turnover of the B idder, should not be less than Rs.416 Lakhs (Rupees Four Crore Sixteen Lakh only) during the preceding three (3)completed financial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criter ia, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net wor th of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an eve

nt, the bidder would be required to furnish along with its T echno-Commercial bid, a Letter of Undertaking from the H olding Company, supported by

Board Resolution, as per the format enclosed in the bid do cuments, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in c ase of award.

1.2.3 The Net Worth of the bidder shall not be less than 10 0% of the bidder's paid up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net Worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of its holding companies wherever applicable, the Net Worth of the Bidder and its Subsidiary(ies) and/or Holding Company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total paid up share capital. 1.2.4 In case the bidder is not able to furnish its audited fin ancial statements on standalone

entity basis, the unaudited unconsolidated financial state ments of the bidder can be considered acceptable provide d the bidder further furnishes the following documents for substantiation of its qualification.

- a. Copies of the unaudited unconsolidated financial statem ents of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- b. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stati

ng that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the compa ny.

1.2.5 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid op ening are not available, the financial results certified by a practicing Chartered Accountant shall be considered accep table. In case, Bidder is not able to submit the Certificate f rom practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required

from the CEO/CFO as per the format enclosed in the biddin g documents stating that the financial results of the Comp any are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Charter ed Accountant certifying the financial parameters is not av ailable.
