- 1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. BUYER ADDED ADDITIONAL TERMS & CONTIONS (ATC)

Qualifying Requirements (QR)

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated her eunder:

1.1 Technical Criteria:

1.1.1 The bidder should be a Boiler (Steam Generator) Manufacturer and should have supplied at least one (1) number of Boiler to any "Thermal power plant".

OR

The bidder should be a Tube Manufacturer approved by Central Boiler Board India, for manufacturing of Co Id Drawn Seamless Tubes of "Alloy Steel" AND/OR "Stainless Steel" and should have supplied Cold Drawn Seamless Tubes of grades "Shot Peened-S304H/ ASTM A213 S30432/ ASTM A213 Grade TP347H" to "Boiler Manufacturer of Thermal Power Plant" or to any "Thermal Power Plant".

Note:

"Thermal Power Plant" must have:

EITHER

"Unit Size of minimum 200 MW"

OR

"Boiler having Maximum Continuous Rated (designed) parameters- more than or equal to Steam Flow 600 Tonnes/hr, Steam Pressure 137 KSC and Steam temperature 535 deg C".

- 1.1.2 The Bidder should have executed the work of Supply of IBR compliant "Boiler" AND/OR "Boiler Tubes " AND/OR "Reheater Tubes/Coils" AND/OR "Superheater Tubes/ Coils" within preceding seven (07) years p rior to the date of Techno Commercial bid opening, in any of the following manner:
- A. One (1) order having executed value not less than Rs.378.0 Lakh.

OR

B. Two (2) orders having executed value not less than **Rs. 236.0 Lakh** each.

OR

C. Three (3) orders having executed value not less than Rs.189.0 Lakh each.

Notes for Technical Criteria:

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specifie d above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bi d opening duly certified by bidder's client shall be considered acceptable.
- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. In ca se contract is inclusive of taxes, bidder should provide the break-up of basic value and taxes.

1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs 472.0 Lakh (Rupees Four Hundred and Seventy Two lakh only)** during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its H

olding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provid ed that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

- 1.2.3 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
 - · Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
 - · A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the biddin g documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Comme rcial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Ac countant certifying its financial parameters, the audited results of three consecutive financial years preced ing the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
